
I would recommend a refusal of this application in its present form on highway safety grounds. The two four bedroom properties have built in garages but with only approximately 3 metres and 3.5 metres respectively between the garage doors and the back of the pedestrian footway. This is insufficient to allow vehicles to pull clear of the highway and footway when entering the driveways and would be a safety hazard to pedestrians and traffic on Longridge Road. A clear 5 metre distance from the back of the footway to the garage doors would be the minimum acceptable.

I am pleased to note that the applicant has shown the existing footway to the south west side of the plot being extended along the frontage of the proposed dwellings and would not accept the removal of this to achieve a 5 metre distance from highway boundary to garage door. If the applicant can modify the proposal so that from the existing kerbline of Longridge road there is a 1.5 metre pedestrian footway and then a 5 metre length of driveway to the door of any proposed garages then I would have no objection in principle to the proposals, subject to the usual conditions relating to gates, surfacing and so forth.
