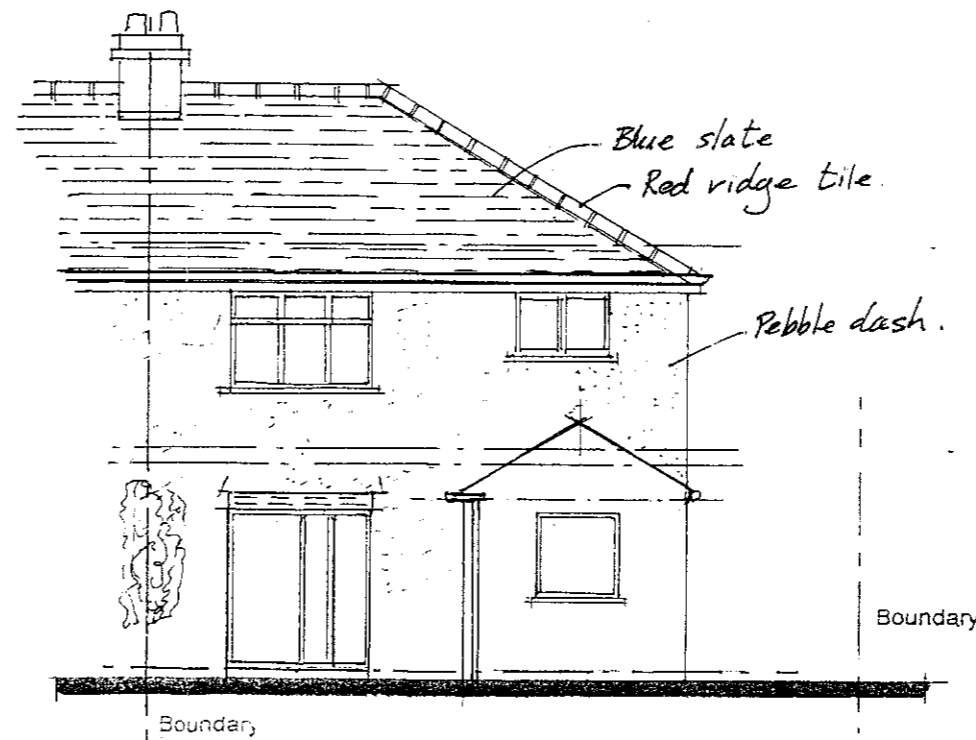


Side Elevation

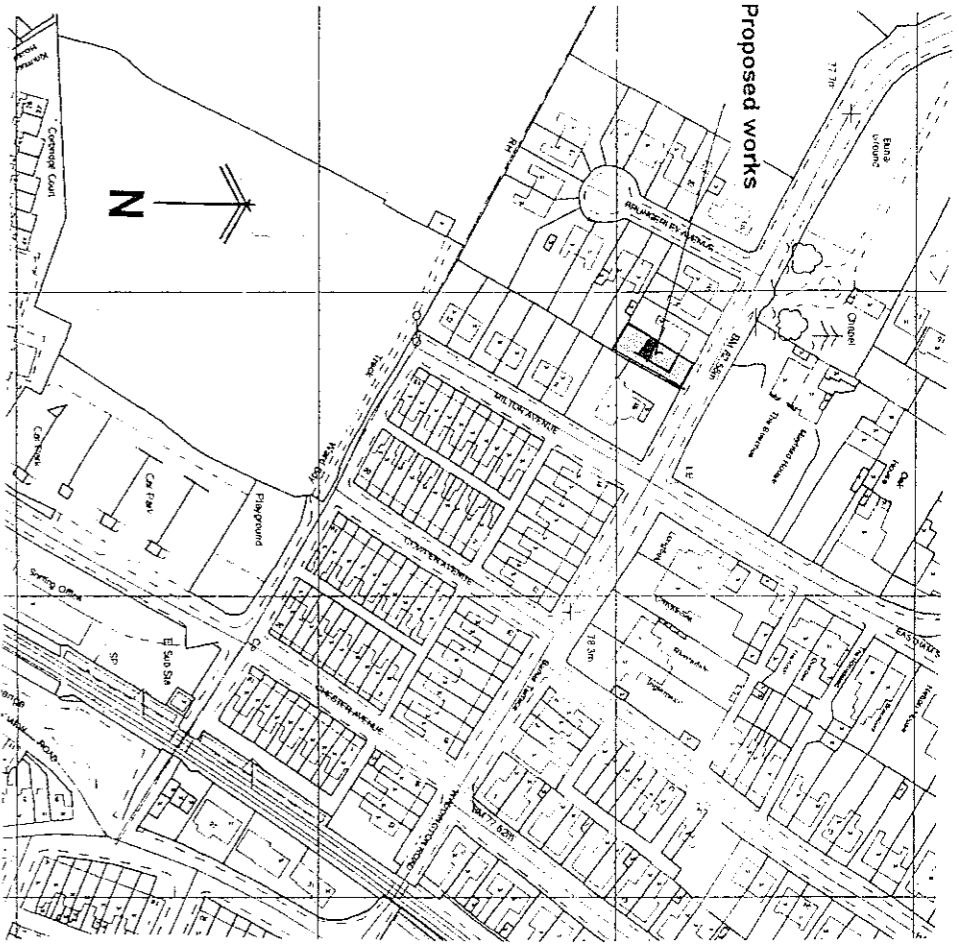

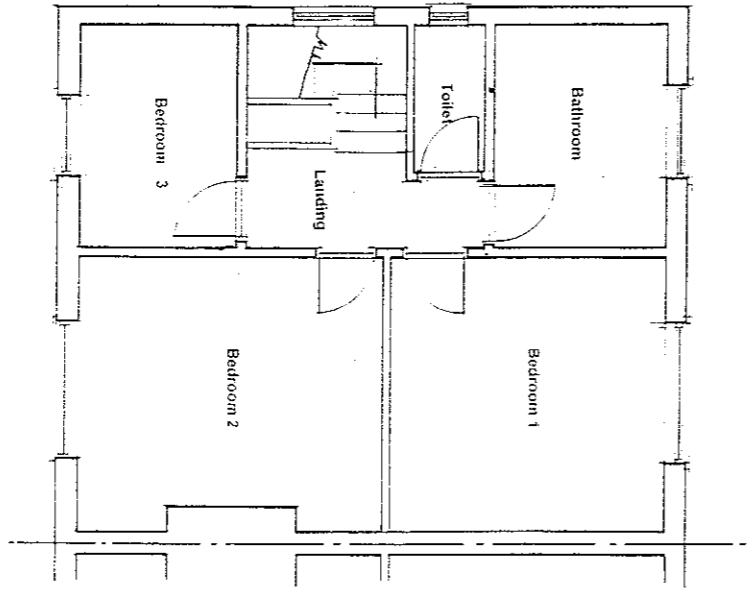

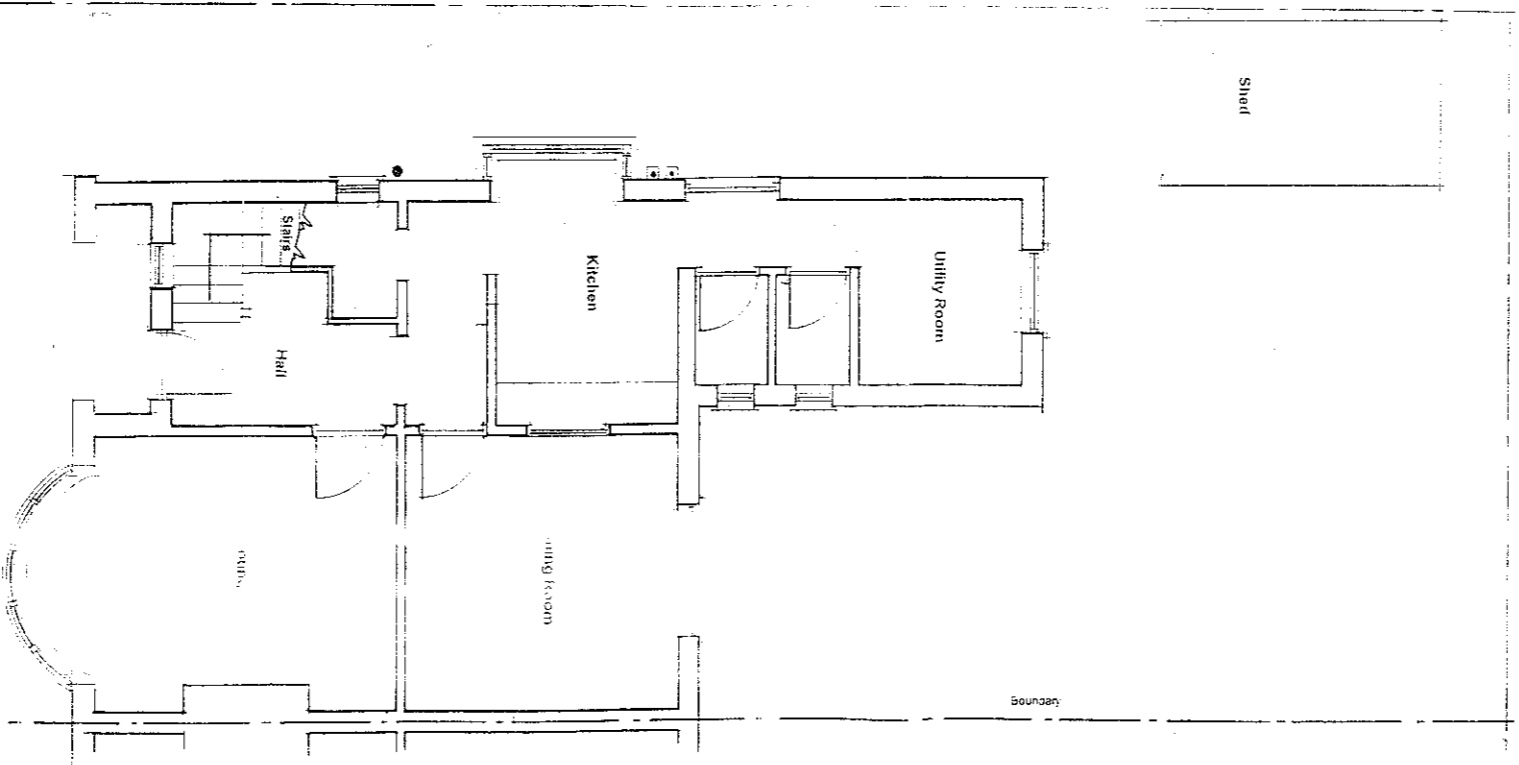


Location Plan
