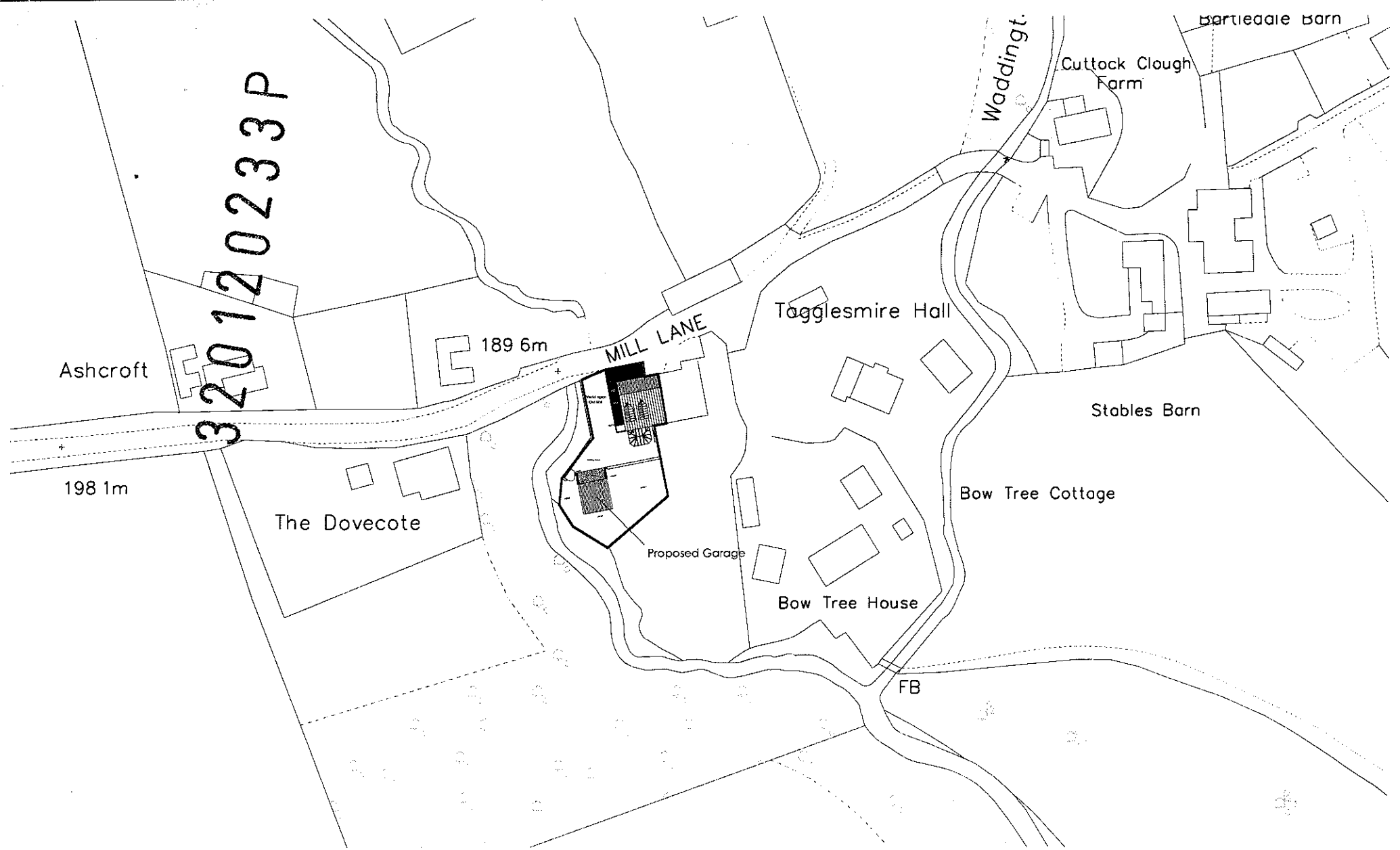

## INTRODUCTION

Waddington Old Mill is a three bedroom, private dwelling to the north of Waddington village. The dwelling was once a mill and has been sensitively converted using reclaimed stone and stone mullion windows to create a private dwelling which sits well with its surroundings. My client has appointed us to extend the property to create an additional bathroom and garage for vehicle and general storage.

## DESIGN

We propose to build a rear extension to Waddington Old Mill to accommodate a downstairs bathroom. The clients' father would greatly benefit from the accessibility of a downstairs bathroom. Natural random stone will be used for the external face of the extension to match the existing property. The roof will be a lead rolled flat roof. This is due to the complicated intersection of roof pitches making another pitched roof difficult. Another benefit of a flat roof is to reduce the impact upon the existing cat slide roof which gives this house the character it has.

We also propose to construct a double garage sited a meter below Waddington Old Mill ground level. The house currently has no garage to store cars or storage for garden tools etc. The garage will be constructed from natural random stone to match the existing house with a natural slate roof. Roof lights will be situated facing West away from neighbouring houses.

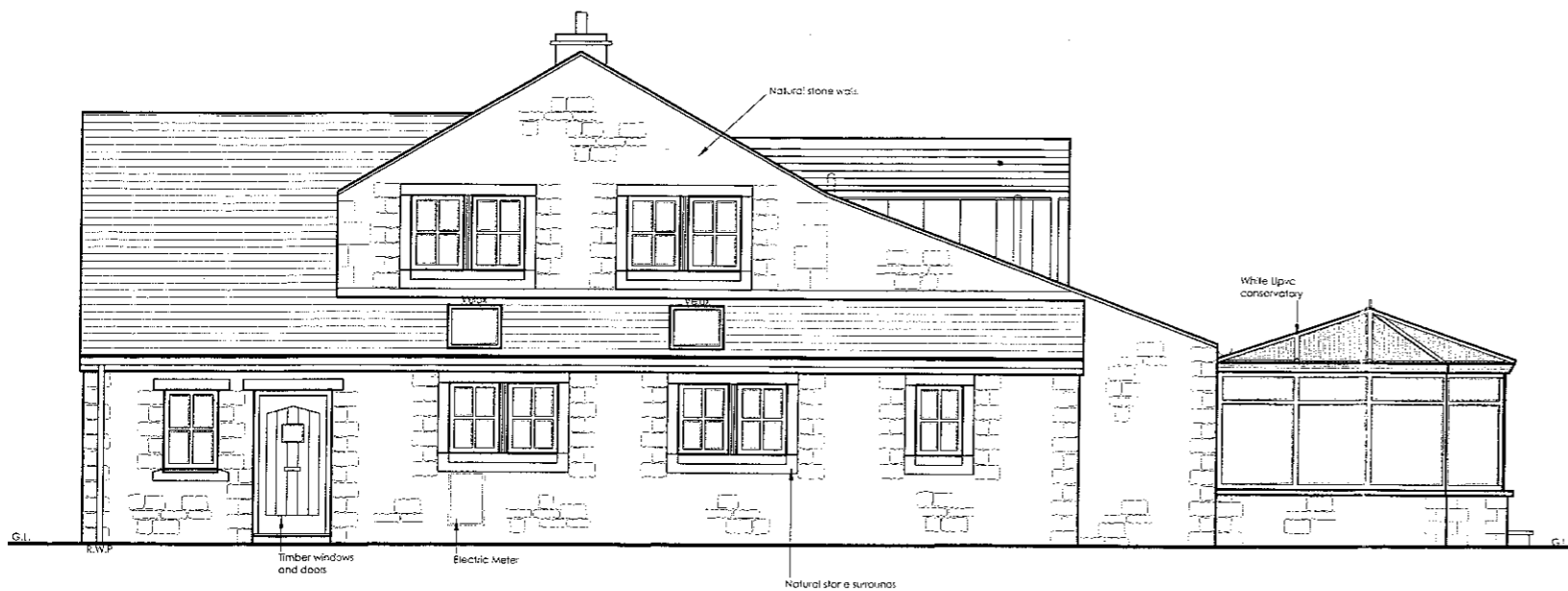
## REVISED DESIGN PROPOSALS

Following the response from the pre-application advice we have revised the proposals by reducing the ridge and eaves height to the proposed garage. We have also moved the roof lights to the West Elevation.

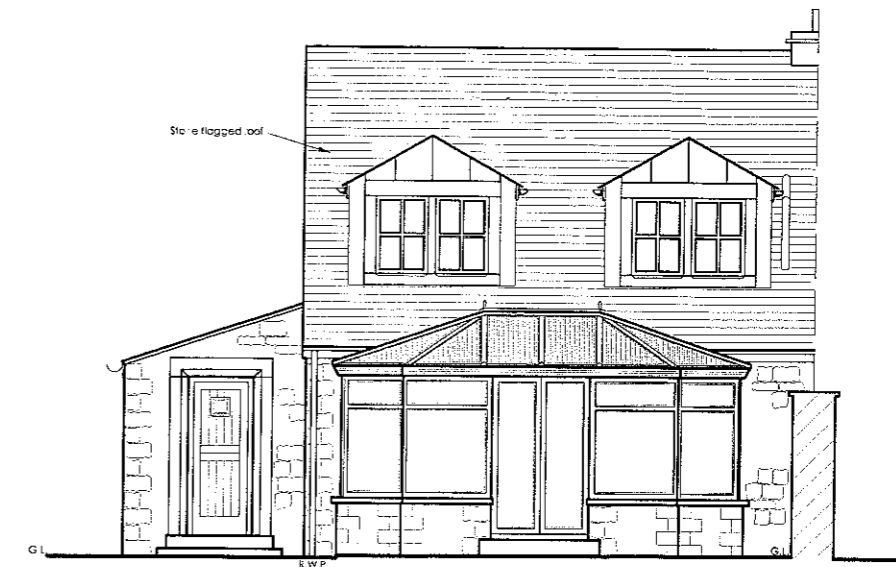
The eaves of the bathroom extension has been designed to not disrupt with the existing rear elevation.

I hope you now find these revised proposals acceptable.

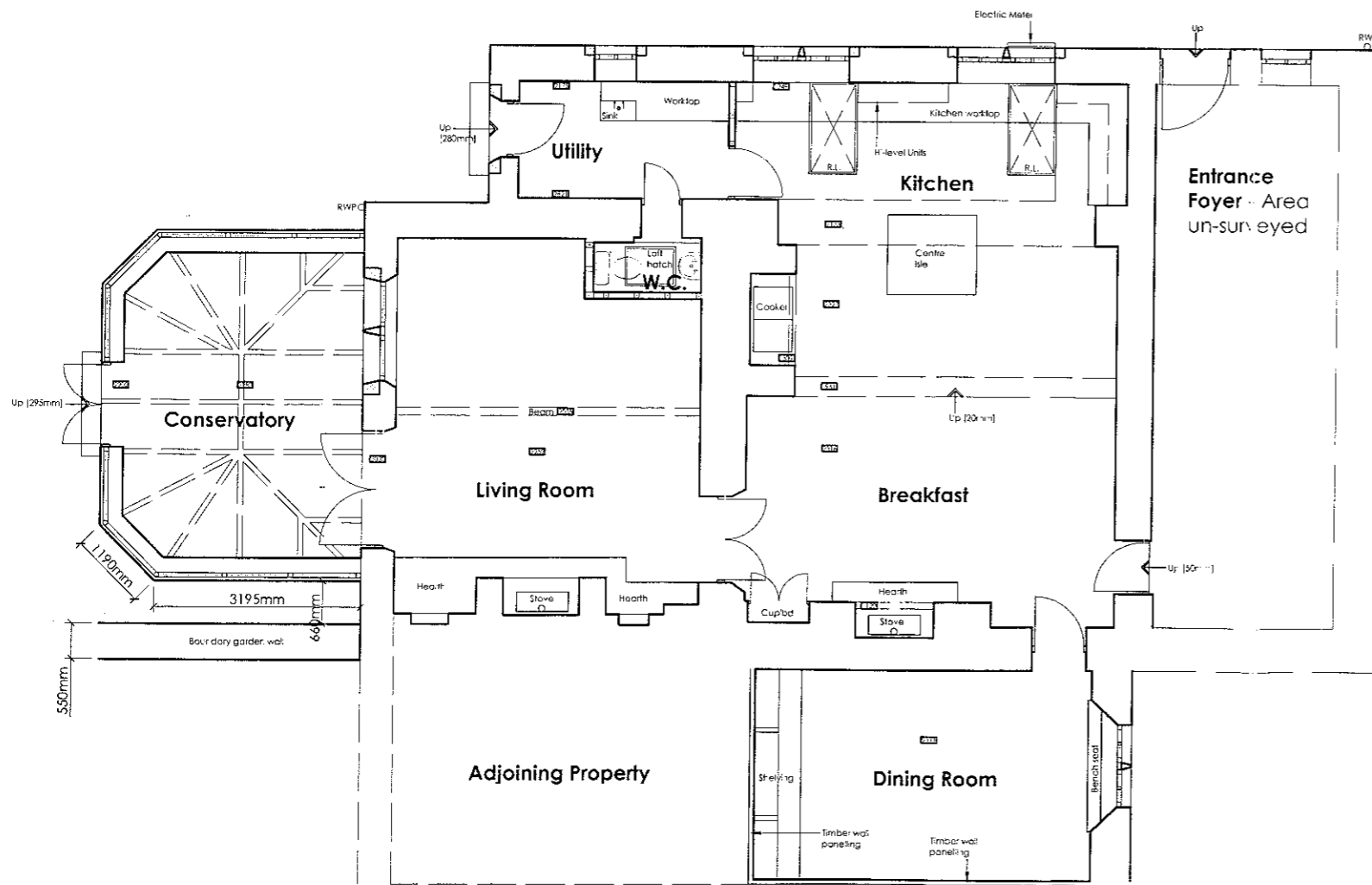





**WEST ELEVATION (Front)**
