'In principle' objection to the development as it precedes the LDF Core Strategy but the letter then sets out the requirements on affordable housing, trees/ecology/biodiversity, highways, POS, design/layout/visual amenity; archaeology; renewables and county council planning contributions on transport and education; and comments on EA and utilities feedback. The pre app meeting was held on 31.7.12 and further information increasing the site area and number of units from 325 to 345 was sent in August to the LPA asking this be considered before reply. The pre app reply of 4.9.12 still refers to 325 units only. A copy of the pre app reply is included in the supporting documents to this application.
