

Designated Landscapes - Forest of Bowland Area of Outstanding Natural Beauty (AONB) This application is within the setting of Forest of Bowland Area of Outstanding Natural Beauty (AONB).

This application is a distance of 1.1 km from the Forest of Bowland Area of Outstanding Natural Beauty (AONB) .Given the location of the development, your local planning authority should seek the views of the AONB Partnership where relevant, prior to determining this planning application, as they may have comments to make on the location, nature or design of this development.

As mentioned in our previous response dated 27 November 2012 ref (68558), Natural England's main concerns relate to the the poor quality of the Landscape and Visual Assessment accompanying the EIA which does not adequately assess the potential impacts of the development on the AONB.

Having considered the Landscape and Visual Assessment within the EIA Natural England does not consider that the Forest of Bowland AONB is shown on the relevant plans and maps showing the visual influence of the proposal. The Landscape and Visual Assessment should include more visual illustrations providing detail of how the AONB will be impacted on from the proposed development. Natural England does not believe that the selected viewpoints adequately show the impact of the proposed development within the siting of the AONB and also how the views from the AONB will be affected. Pendle Hill is very well used by walkers whose visual amenity is likely to be affected by this development. Natural England would therefore welcome more viewpoints from within the AONB, particular from high elevations on Pendle Hill.
