There have been subsequent discussions with RVC Planning to agree that the revised design meets with their approval. This has taken place mainly through email correspondence with their Officer Graeme Thorpe who responded in an email of 25th September 2012 to advise that the retention of the existing hedgerow would be welcomed, the separating distance between the new affordable properties and the existing houses opposite would be acceptable given the difference in level between the development site and the properties opposite. Comments have also been received regarding the preference for a more traditional approach to the elevations of the proposed units
