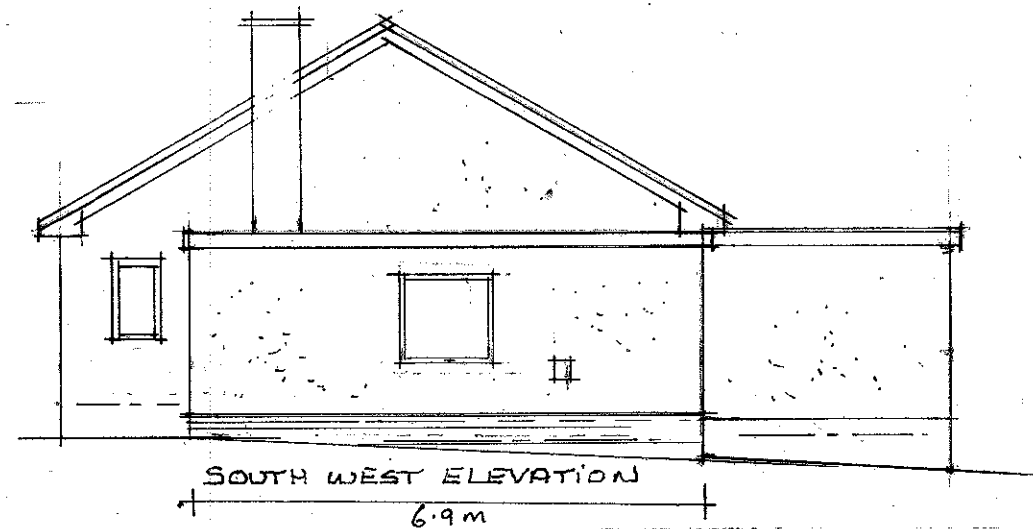

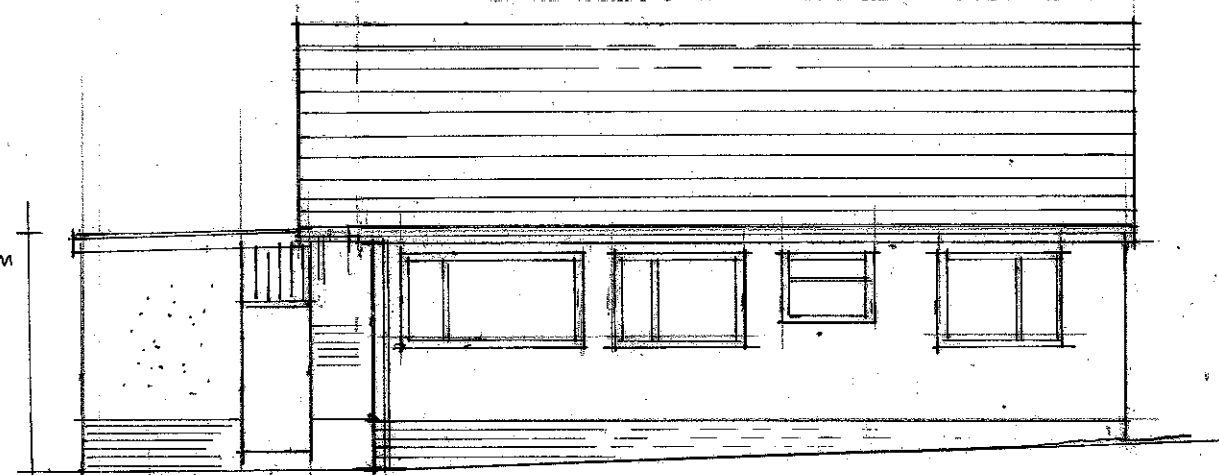
BOUNDARY

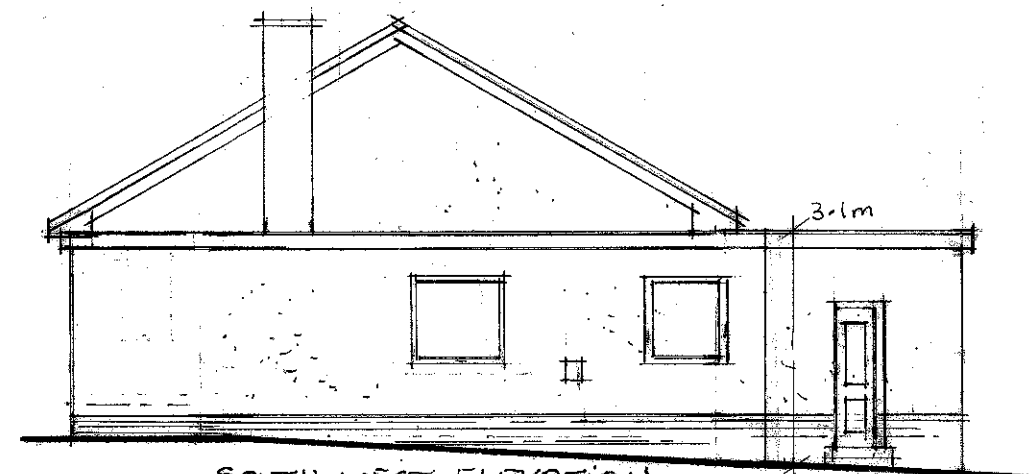

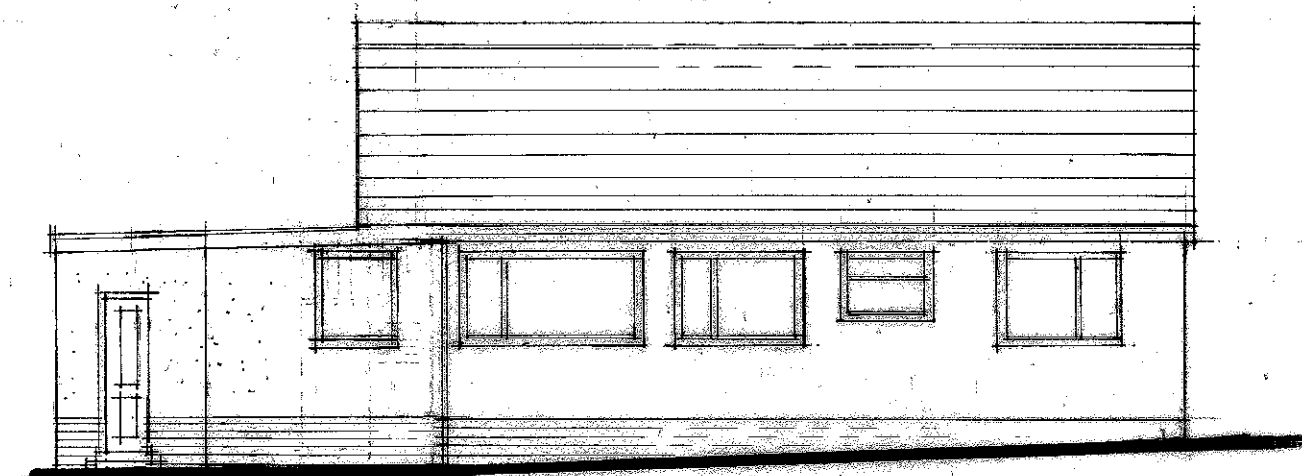
