

With regards to your enquiry concerning the recording condition attached to the planning permission, having read through the Structural Survey and Design & Access Statement it is apparent that, due to the recent rebuilding and alterations to the building, my comments regarding the building still being of archaeological/historical interest are incorrect, and this is a conclusion I should have reached when I first saw the application. I consequently do not consider that the building merits any recording, and will be contacting Mr Baldry at Ribble Valley Borough Council to inform him of my error, and recommend that the planning condition should therefore be discharged.
