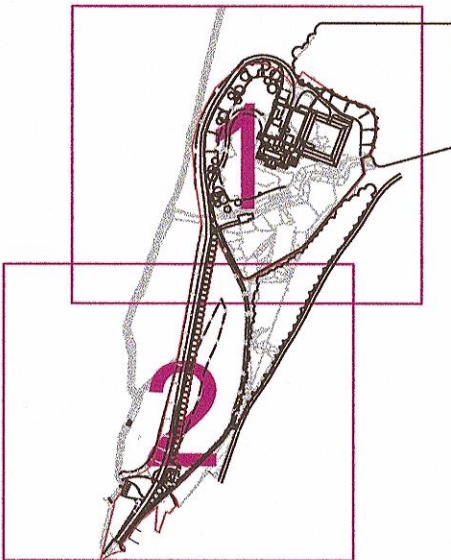
Notes
