COMMENTS/ENVIRONMENTAL/AONB/HUMAN RIGHTS ISSUES/RECOMMENDATION:

Consent is sought for the discharge of condition 10 on application 3/2010/0283/P which detail the replacement of three existing maintenance sheds with the proposed two bay workshop and office for a small coach business including change of use from B8 to B2 use at a site within the AONB. The condition sought for discharge requires that no works take place on site until the applicant or their agent or successors in title secure the implementation of a programme of archaeological works with the work being carried out in accordance with a written scheme of investigation, which has first been submitted to and agreed in writing by the Local Planning Authority. Works have commenced on site with details submitted with this application identifying by way of a sworn statement from the contractor and thus whilst I am mindful that the condition seeks approval of works prior to commencement of development, I do not consider these works in themselves go the heart of the permission and thus consideration of this application can be given. I am mindful of the comments of LCAS who recommend that the condition not be discharged until such time the on-site works and their reporting has been completed. However, the condition requires in

the first instance the submission of and approval of a written scheme of investigation. That is what has been submitted under this application and thus I consider that a partial discharge can be given, however there will remain the need to carry out the works in accordance with the scheme so approved.

RECOMMENDATION: That condition 10 be partially discharged.
