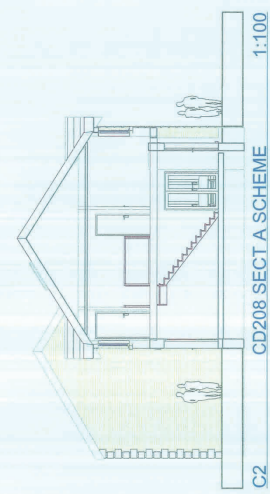

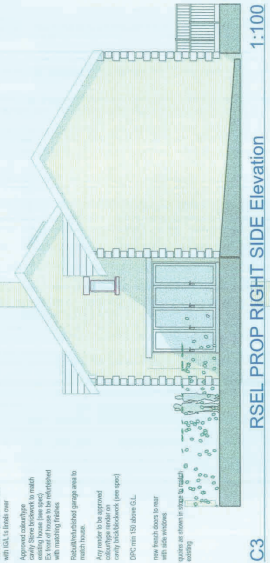

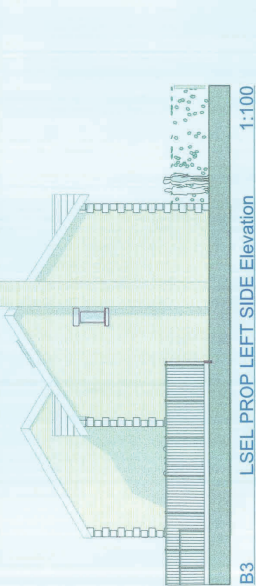
C1 FEL PROP FRONT Elevation 1:100

C3 RSEL PROP RIGHT SIDE Elevation 1:100

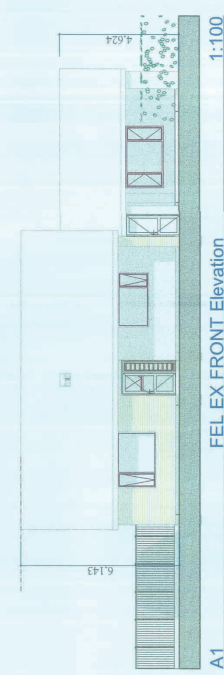

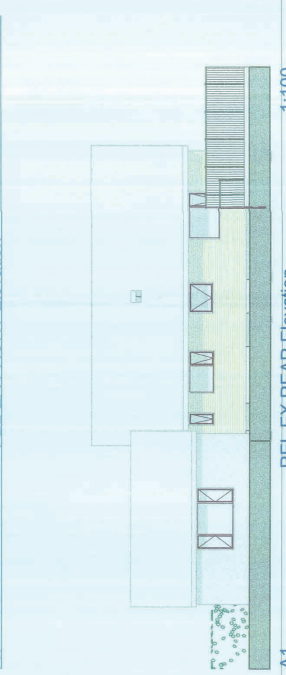

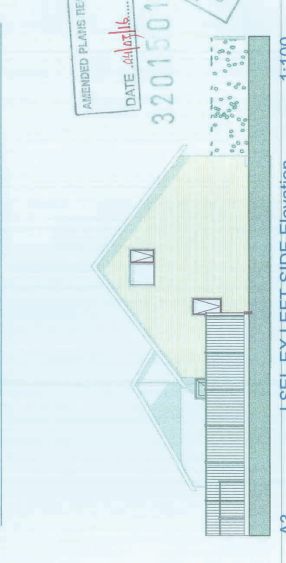
A1 FEL EX FRONT Elevation 1:100
