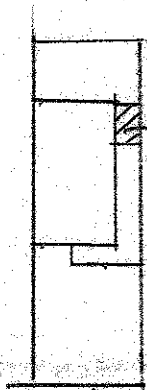

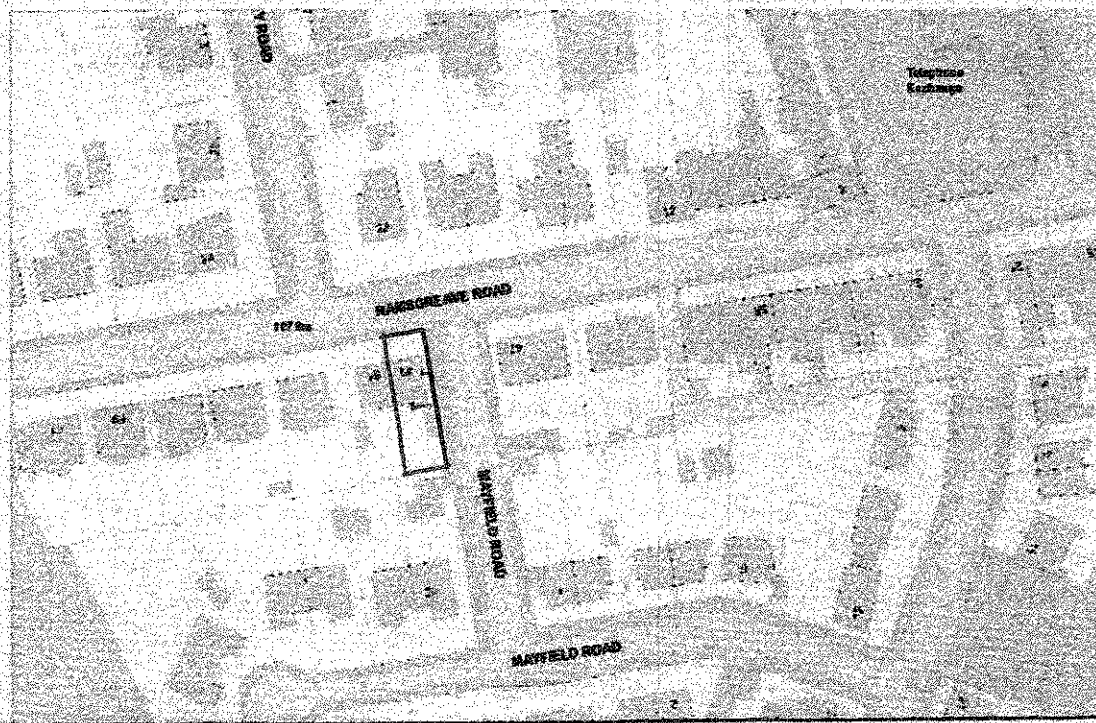

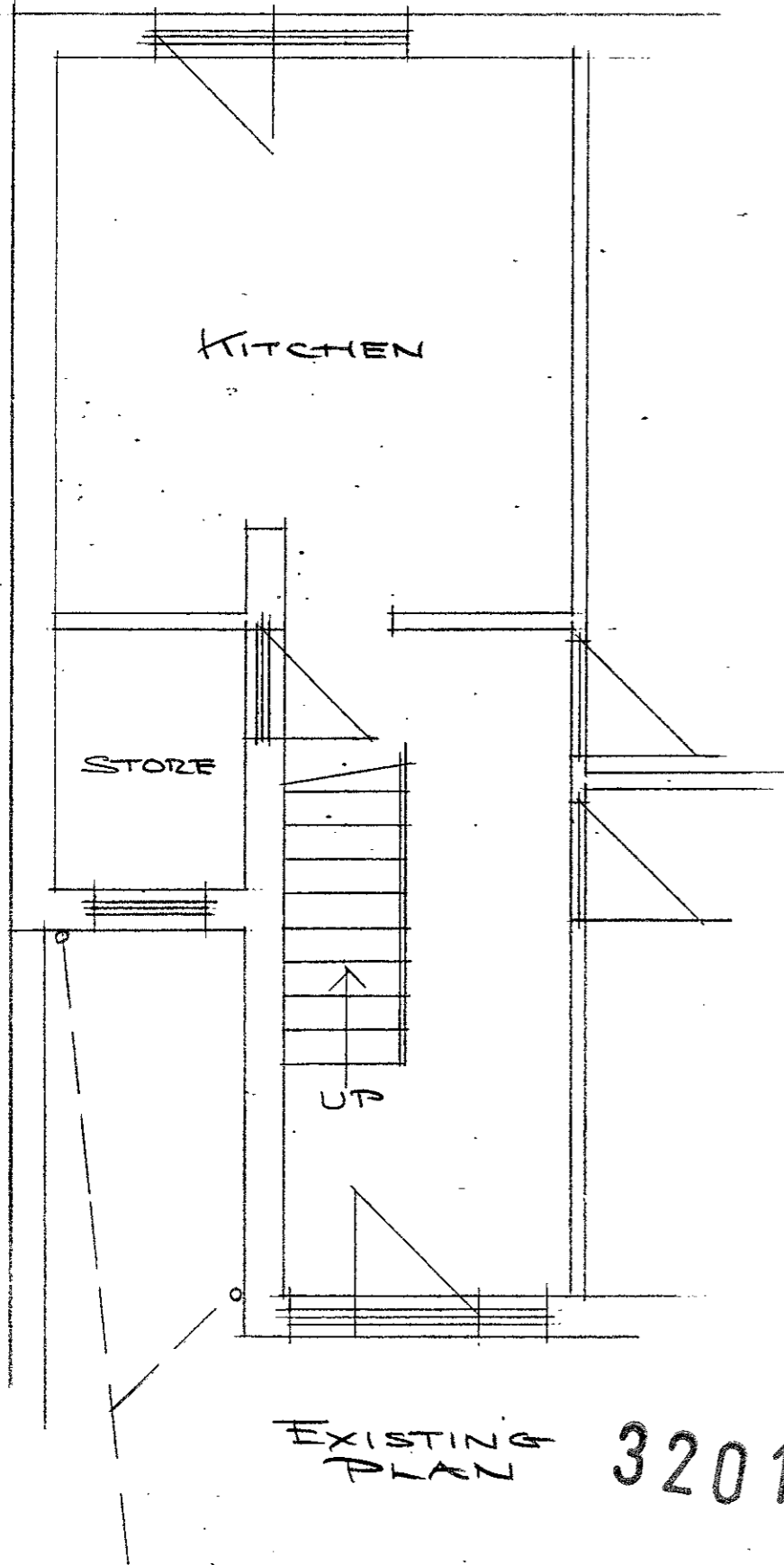

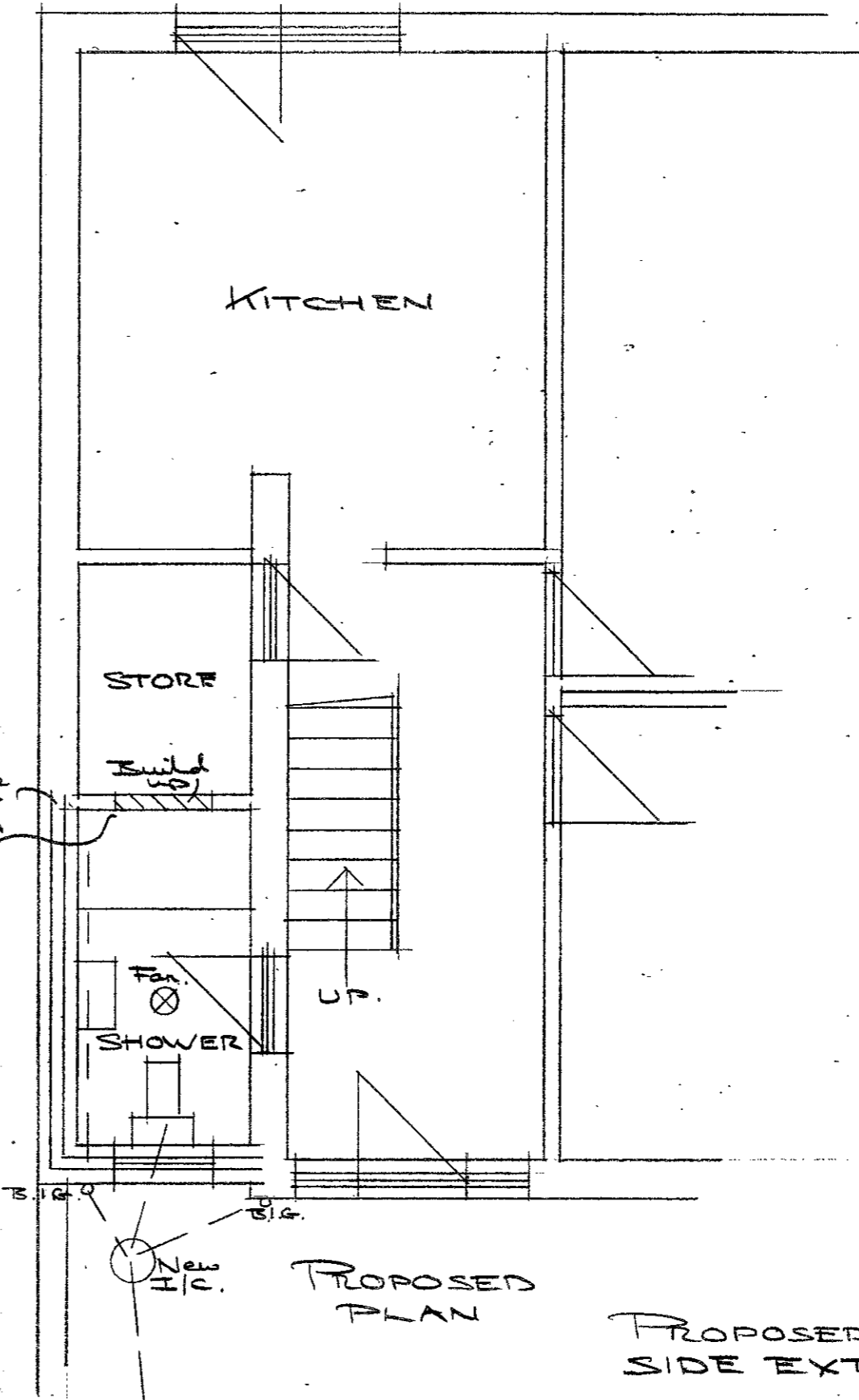

EXISTING PLAN 320150226P

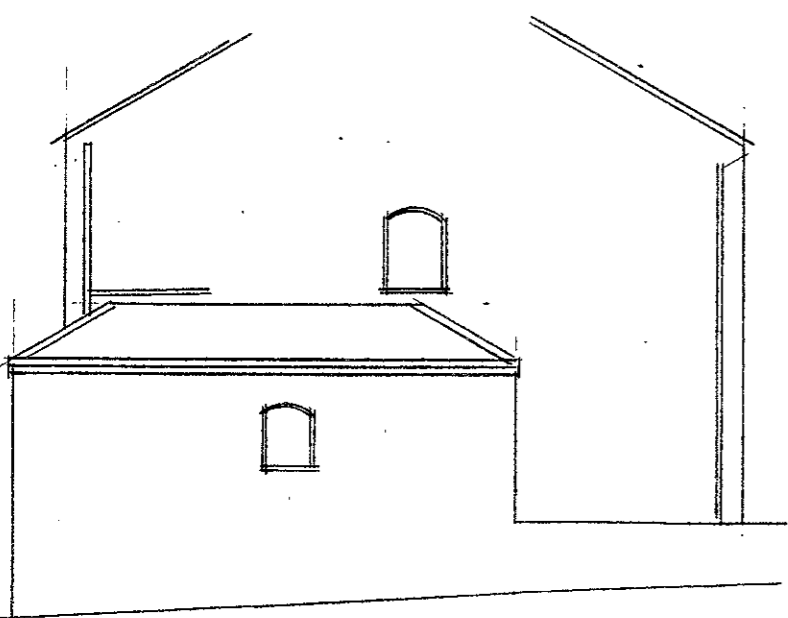


PROPOSED PLAN

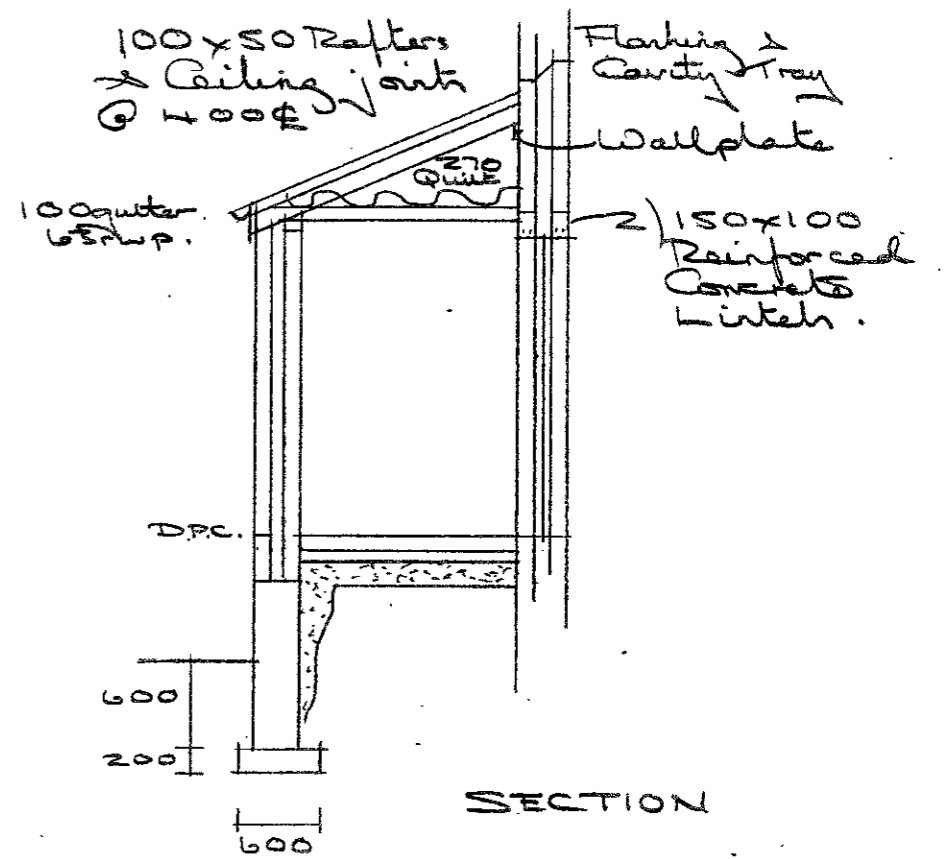

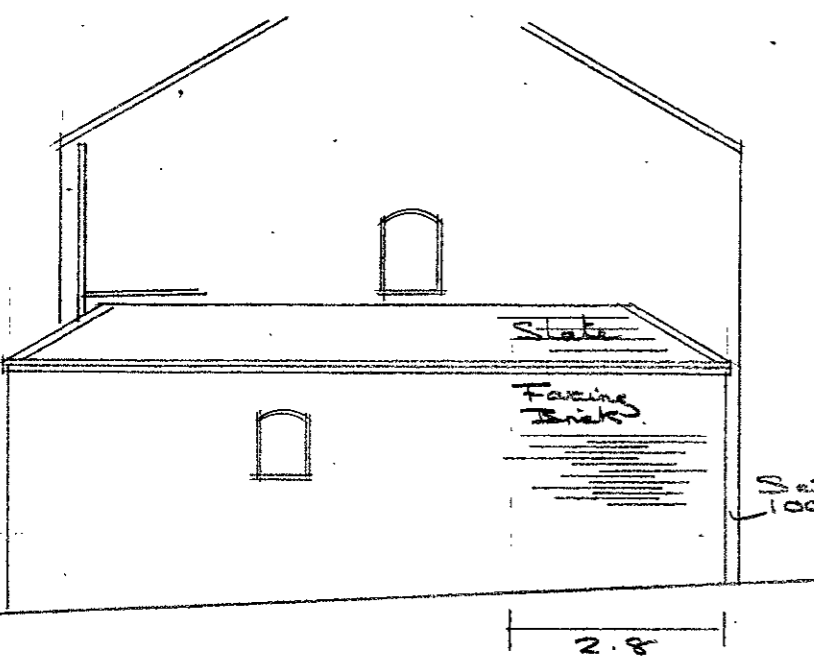
EXISTING SIDE ELEVATION



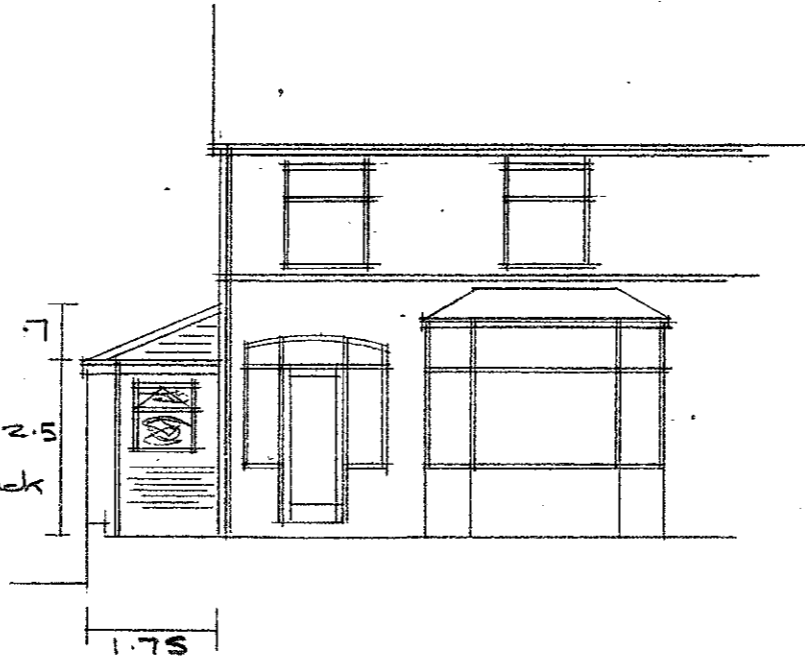
EXISTING FRONT ELEVATION
