The application is to rebuild the previously dismantled element of the mill pond wall to match the remainder. Drain mill pond to enable 'puddling' – repair works to the clay base of the pond to stop leaks, to inspect overall structure and de-silt. Removal of all vegetation growth to the SE corner of the pond excluding large mature trees to the pond edge.

The site is subject to a TPO, in a Conservation Area, a Listed Building, on contaminated land, and within Flood Zones 2 and 3.
