

The purpose of this notification is to ensure that the local planning authority is made aware of the minor development. No formal full planning or GPDO application is required for this type of development and there is no right of refusal involved in such a notification.

The proposed development comprises the following:

- 1) Installation of 1 no. new equipment cabinet, whose cumulative volume does not exceed 90 cubic metres, within existing compound.
- 2) Minor ancillary works.
