the garden and the access lane, which is already showing a crack to the stonework. The tree has leaning and most branches are worsening this situation. The lane is also a public footpath and accessed by local horse riders as well as owners of houses adjacent. We are very concerned with the situation regarding possible damage and safety in general to people and property. We would ensure a tree surgeon would take down the tree in a safe and professional manner as expected by RVBC, and
