'As the proposal is within the settlement boundary of Clitheroe, and (in my opinion) there would be no materially damaging effect or loss of assets, then the principle of conversion is acceptable in principle.
I am supportive of the design and materials proposed for the rear extension. Although Policy DMH4 states that conversion must be of a 'sufficient size to provide necessary living accommodation with the need for further extensions which would harm the character or appearance of the building' – I am of the opinion that the proposed extension would not harm the character or appearance of the building, as it appears subservient to the original barn, whilst using a modern approach.'
