Condition 3

Condition 3 states:

"Precise specifications and samples of proposed mortar to be used in works to the 'Kirk Mill and its associated mill ponds, retaining walls, outflow and stone-built leat' listed building including mortar mix and pointing type (the latter to be submitted in form of a sample panel) shall be submitted to and approved in writing by the Local Planning Authority before its use in the proposed works."

The Specifications for the External Envelope Repair Works report has been submitted to discharge this condition.

Condition 11

Condition 11 states:

"Precise specifications of any works to the listed building's water wheel and its housing (including the removal of the historic fabric to provide views of the water wheel) shall have been submitted to and approved in writing by the Local Planning Authority before implementation of this element of the proposal".
