Please describe the proposed development including any change of use:

The existing asbestos roof is leaking and has been assessed by a surveyor as unsafe. We plan to re roof it using 132mm thick insulated steel faced roof panels which have a u-value of 0.20. the asbestos will be disposed of by a company which will comply with all relevant guidelines.

To reopen 1 existing window, to the rear of the building, which is currently blocked off.

To reopen a door, to the rear of the building, which is currently blocked off.

To replace the front door and window and a window to the side of the property which are constructed of single glazed glass and wood. The frames are rotten and are beyond repair.

The current energy rating of the buliding is lower than G, we intend to improve the rating to a C rating (over the E rating required by the 2018 EPC regulations).

In addition to the more significant changes the building will be re-rendered in a similar fashion to the exsiting colour, but to include the currently unrendered (bare block) walls which look unsightly. The building will also be fully repaired.

The current parking situation on Warwick Street is appalling, once Central garage is occupied it can offer 8 parking spaces, 2 for employees and others for customers. We are open to the idea of allowing other local businesses to utilise the parking.
