Erect a 2.0m high wooden post & panel fence from the rear left hand corner of our garden which joins to our rear boundary wooden fence. This fence would then run alongside the footpath to the left side of our rear garden and the left side of our property. It would be approx 0.7m in from our existing left side boundary and would end when it reaches the line of the front elevation of our property. At this point it would join to a fence or wooden gates that run parallel with the front elevation of our property. The fence will then be hidden from view by a continuous (minimum 2.2m high) dense laurel evergreen hedge along & beyond its entire length as it runs parallel to the footpath.
