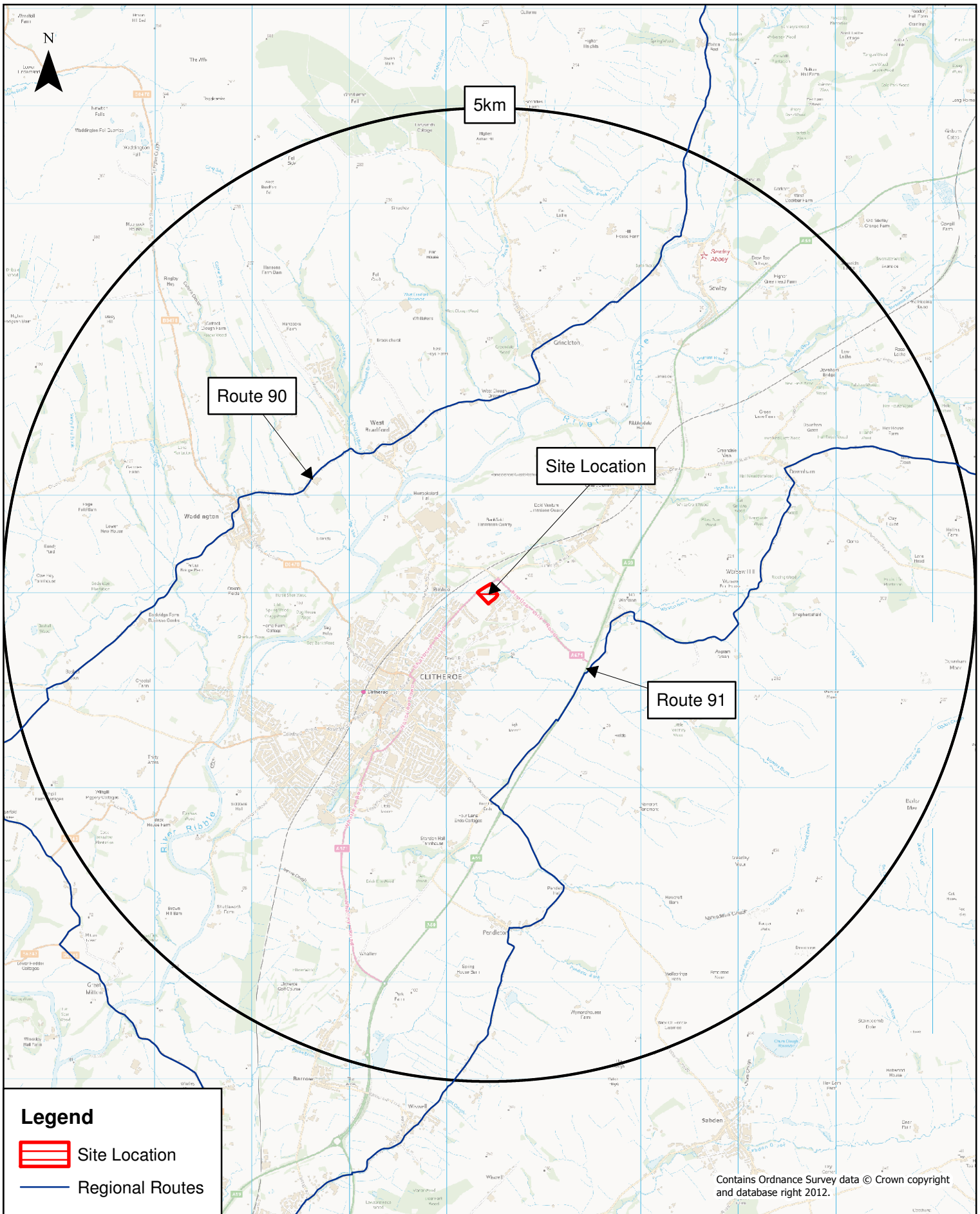

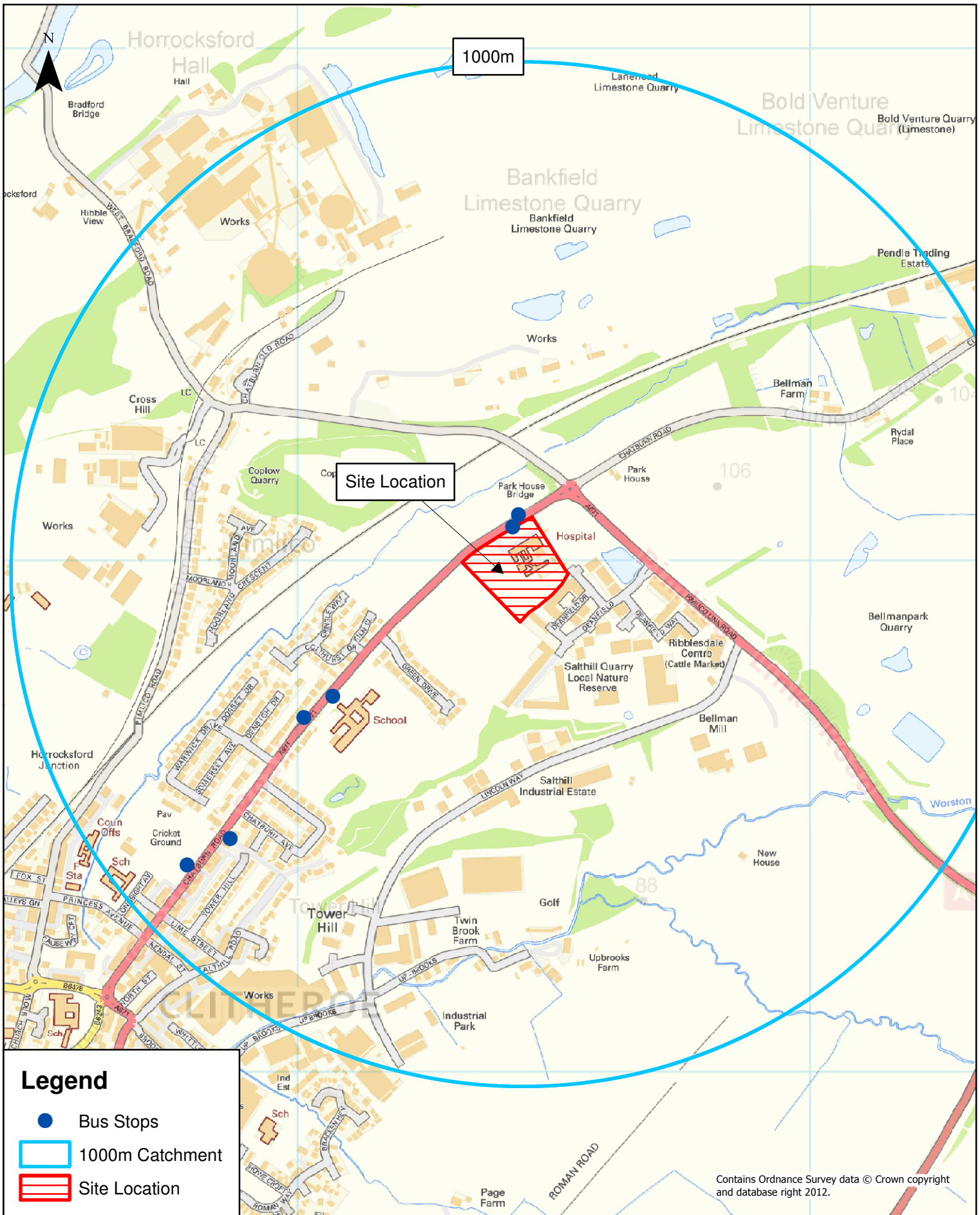

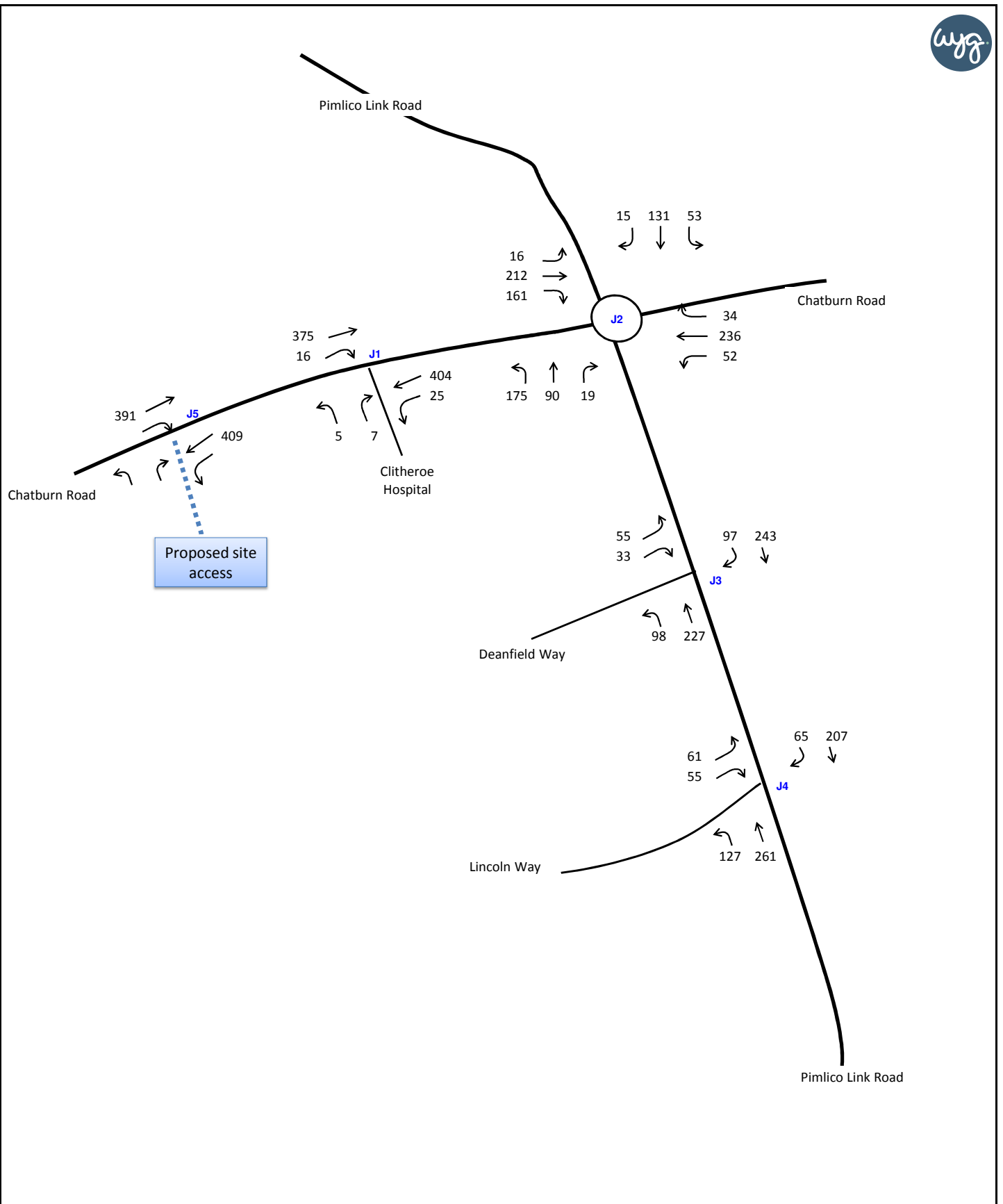


Figure 1: AM Peak Hour 2015 Surveyed Flows (0800-0900)

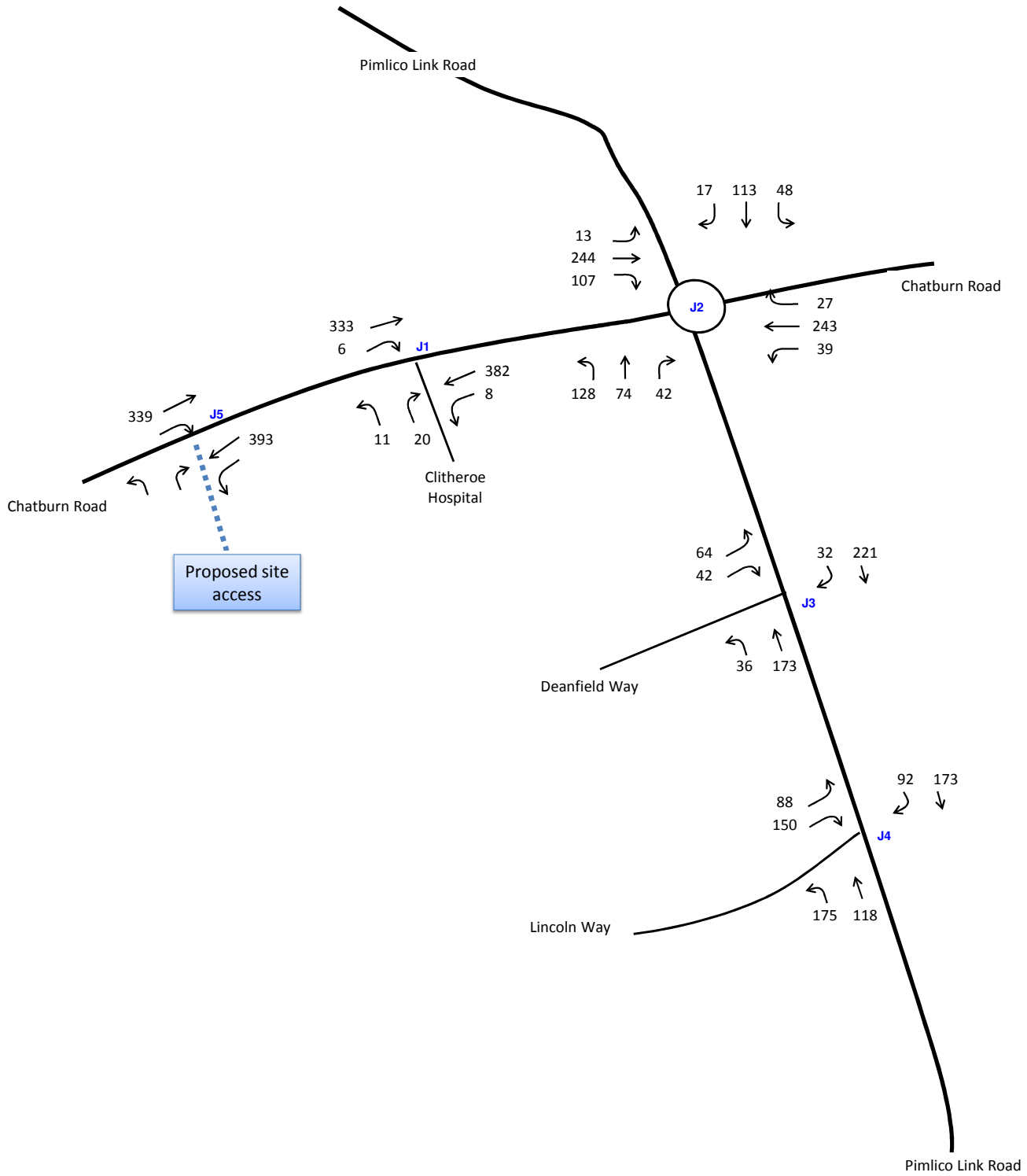


Figure 2: PM Peak Hour 2015 Surveyed Flows (1545-1645)

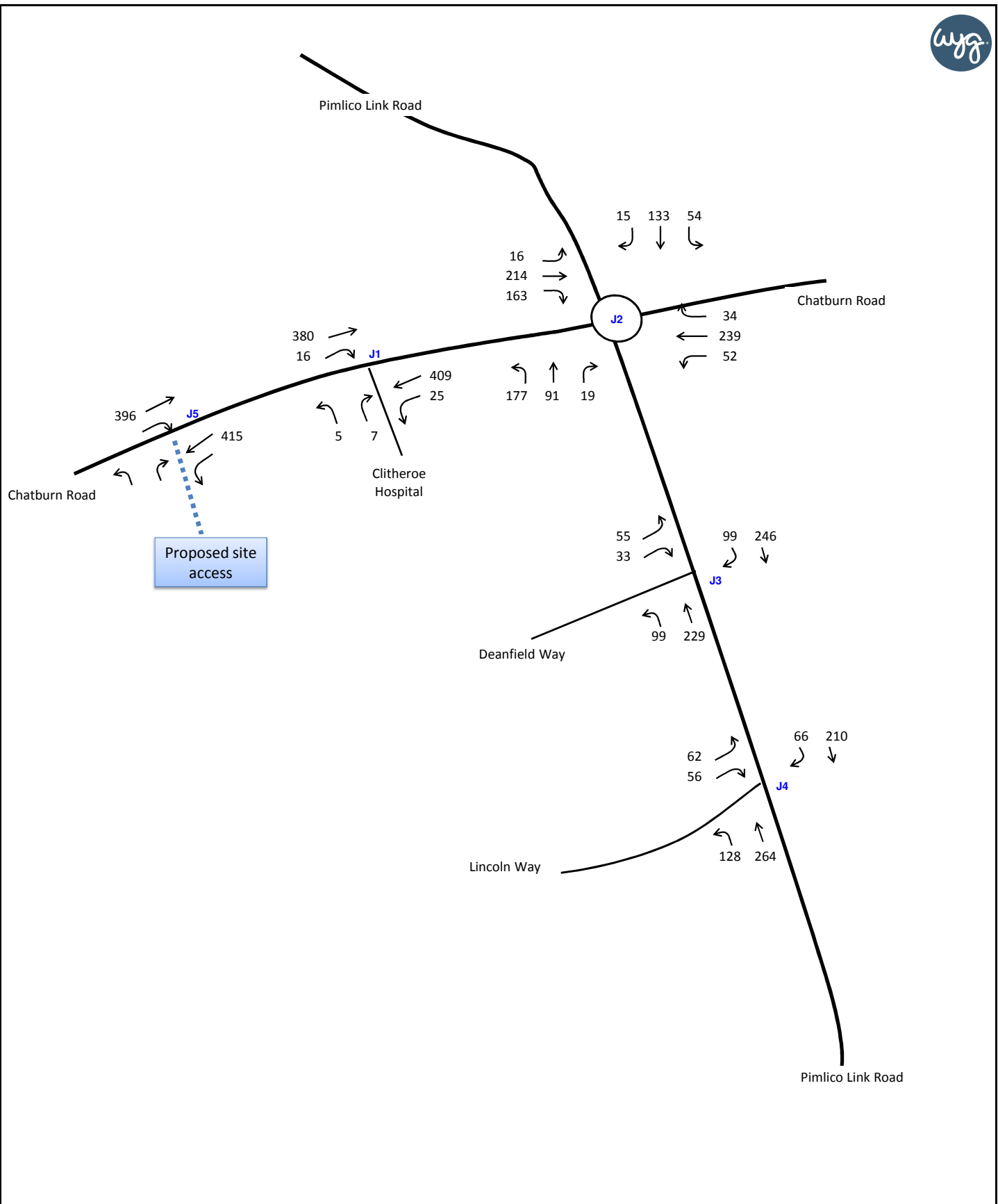
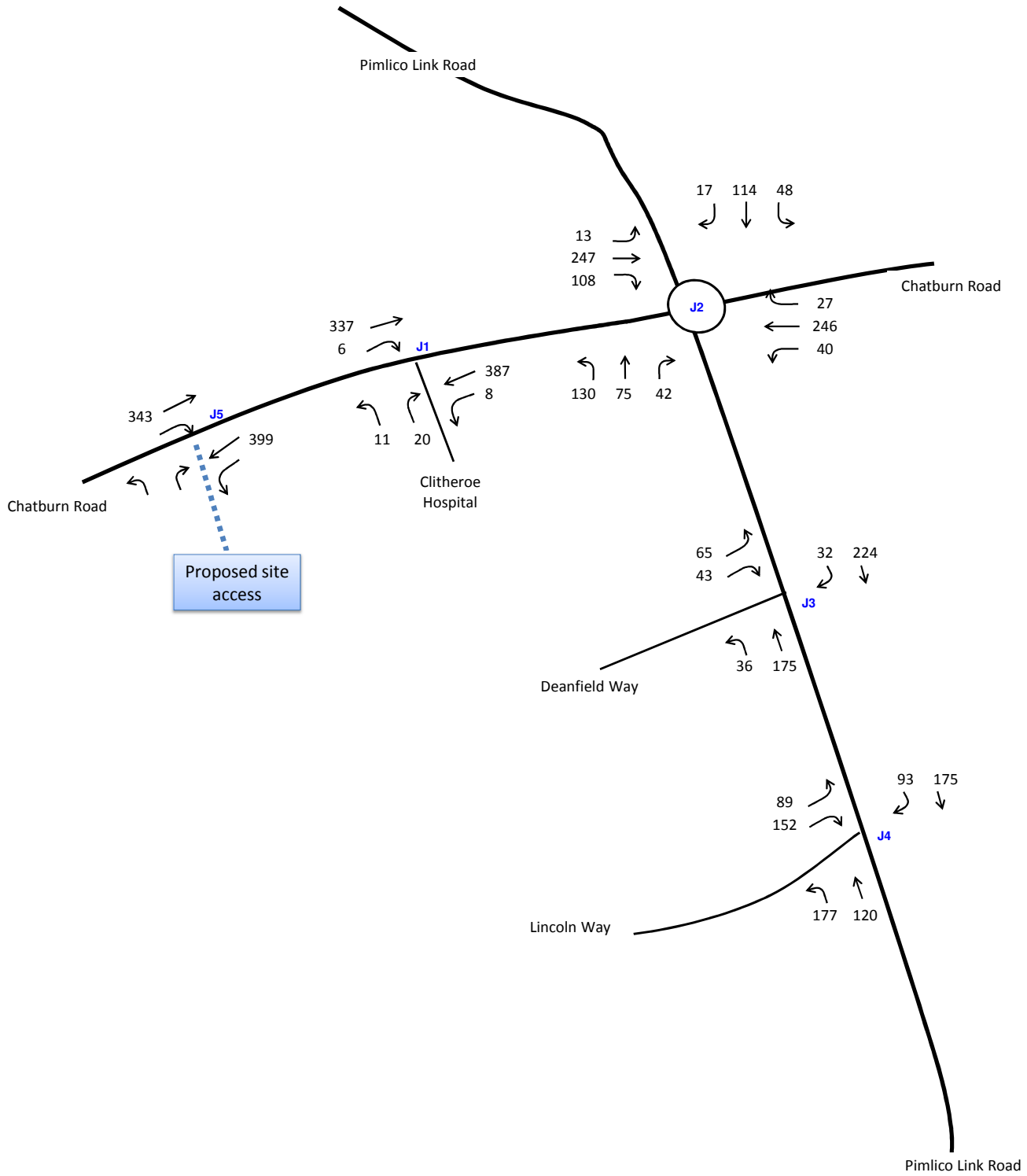


Figure 3: AM Peak Hour 2016 Growthed Surveyed Flows (0800-0900)



**Figure 4: PM Peak Hour 2016 Growthed Surveyed Flows (1545-1645)**



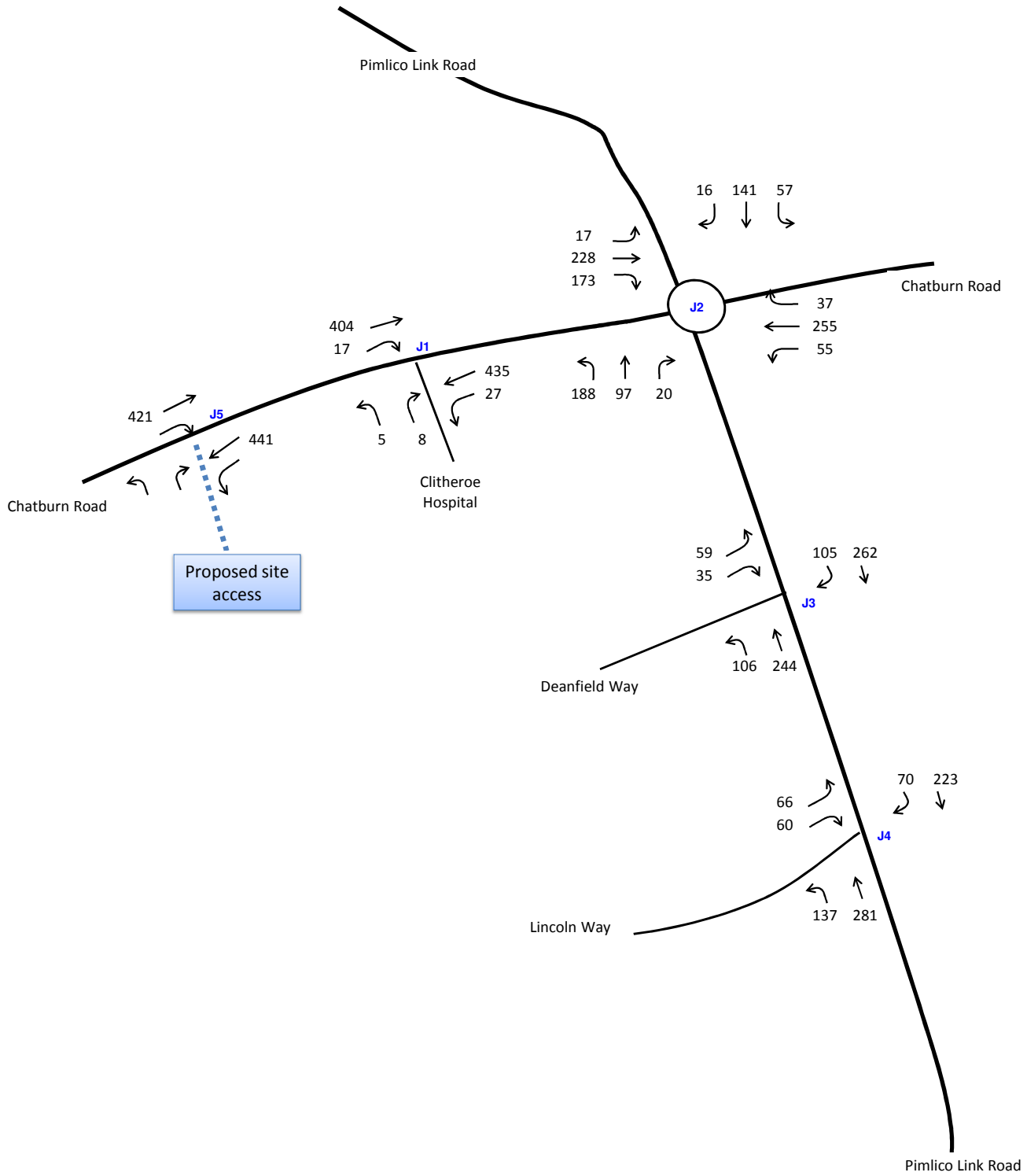
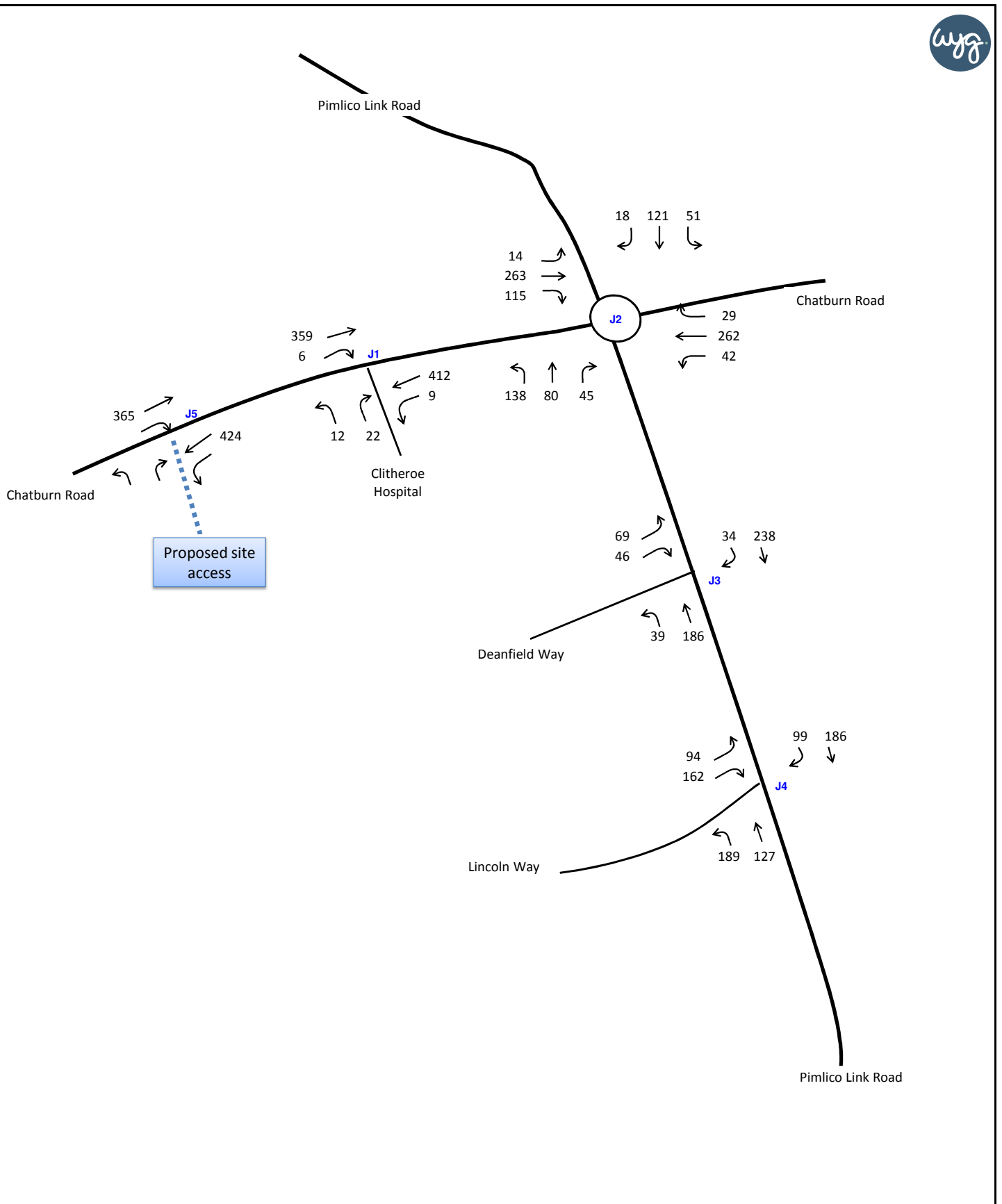
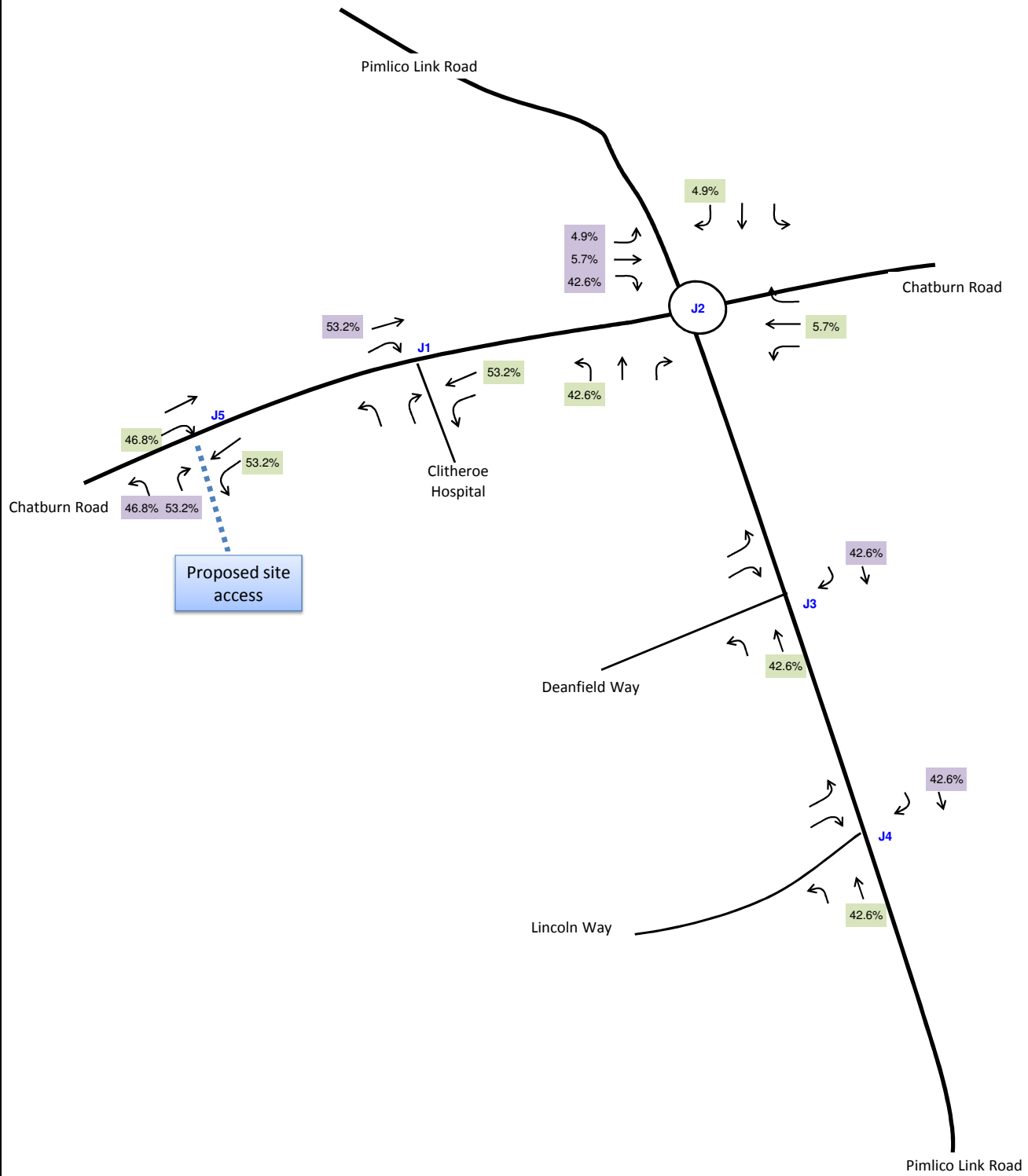


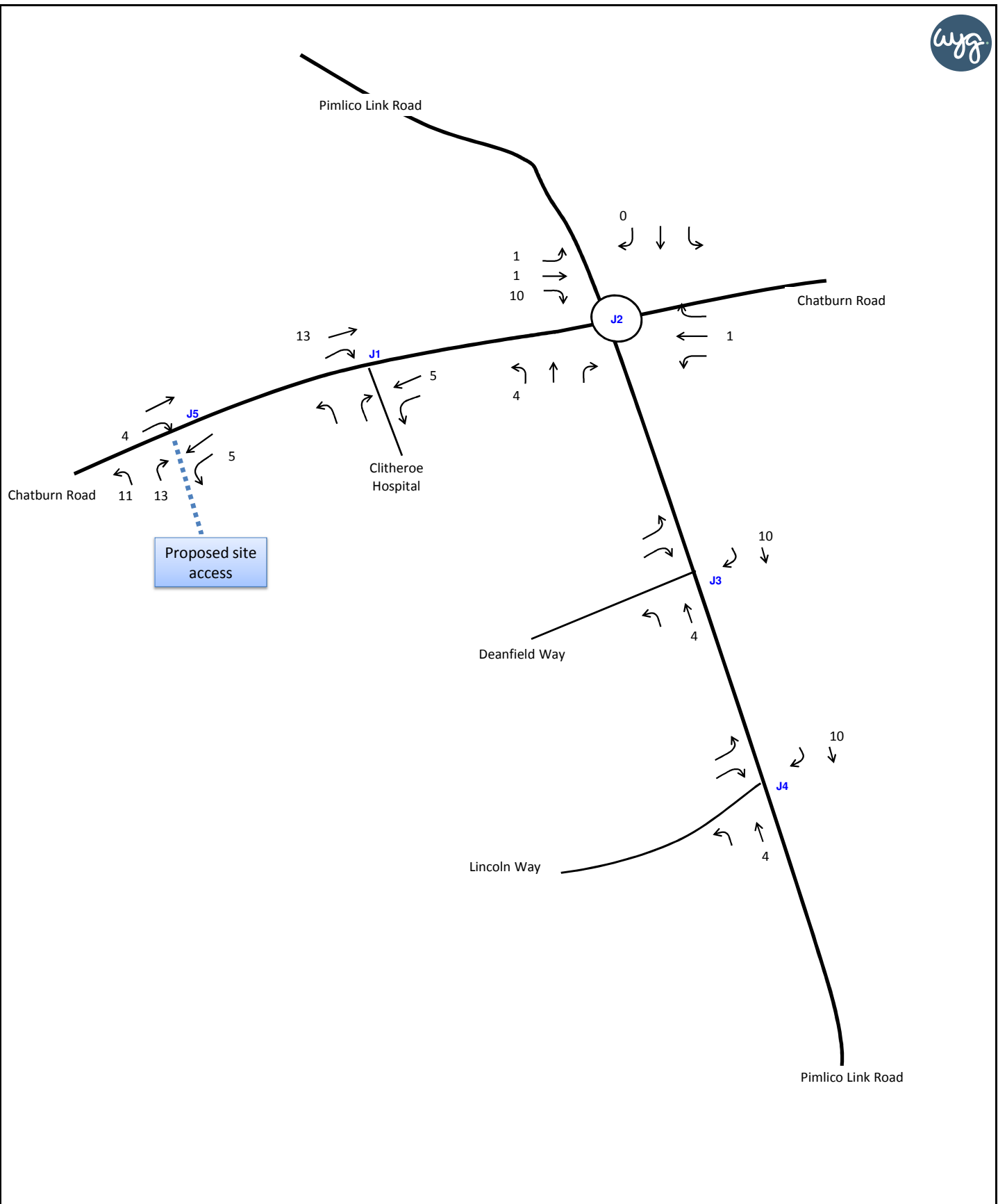
Figure 5: AM Peak Hour 2021 Growthed Surveyed Flows (0800-0900)

**Figure 8: AM Peak Trip Generation (60 Dwellings)**



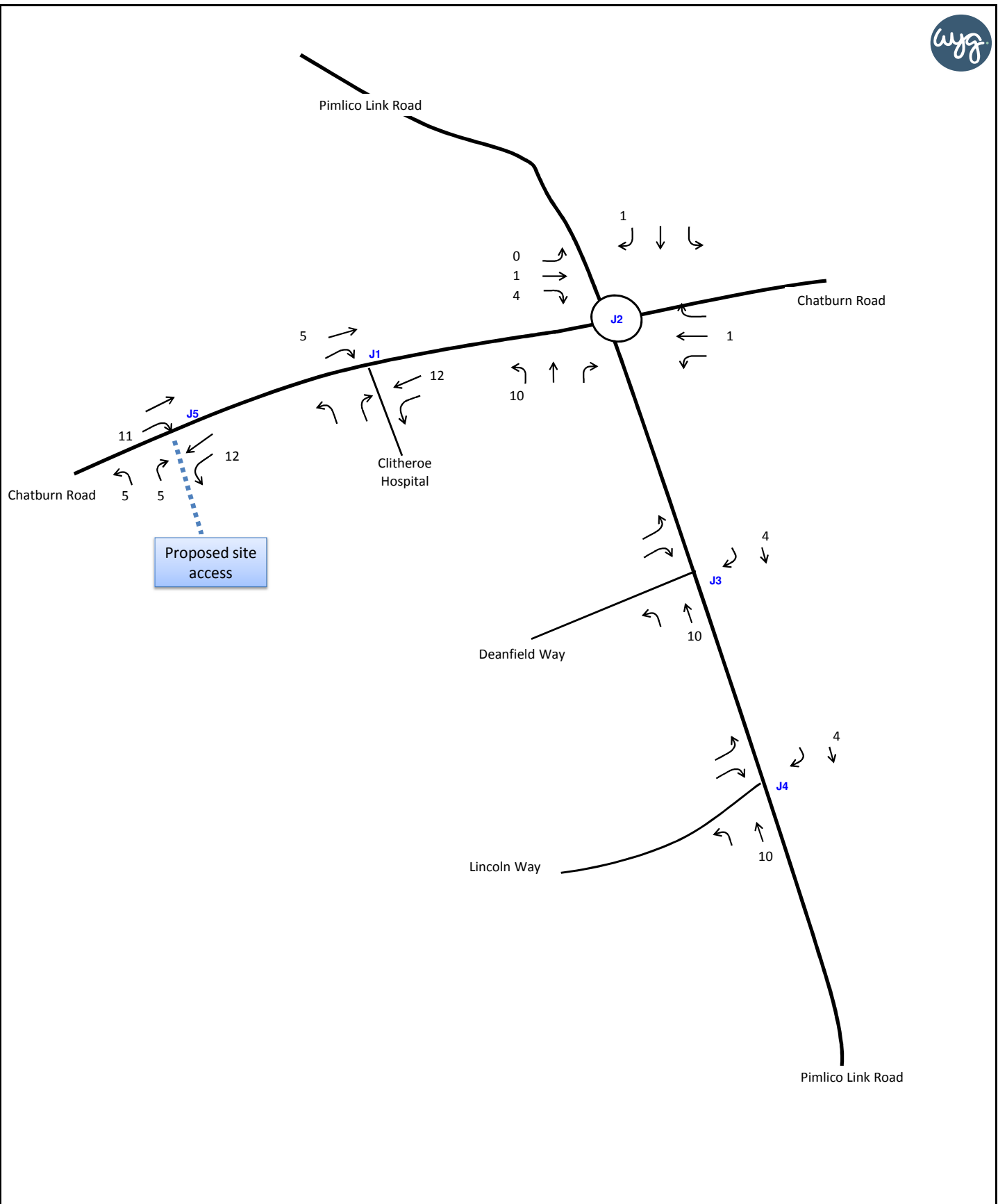


Figure 9: PM Peak Trip Generation (60 Dwellings)

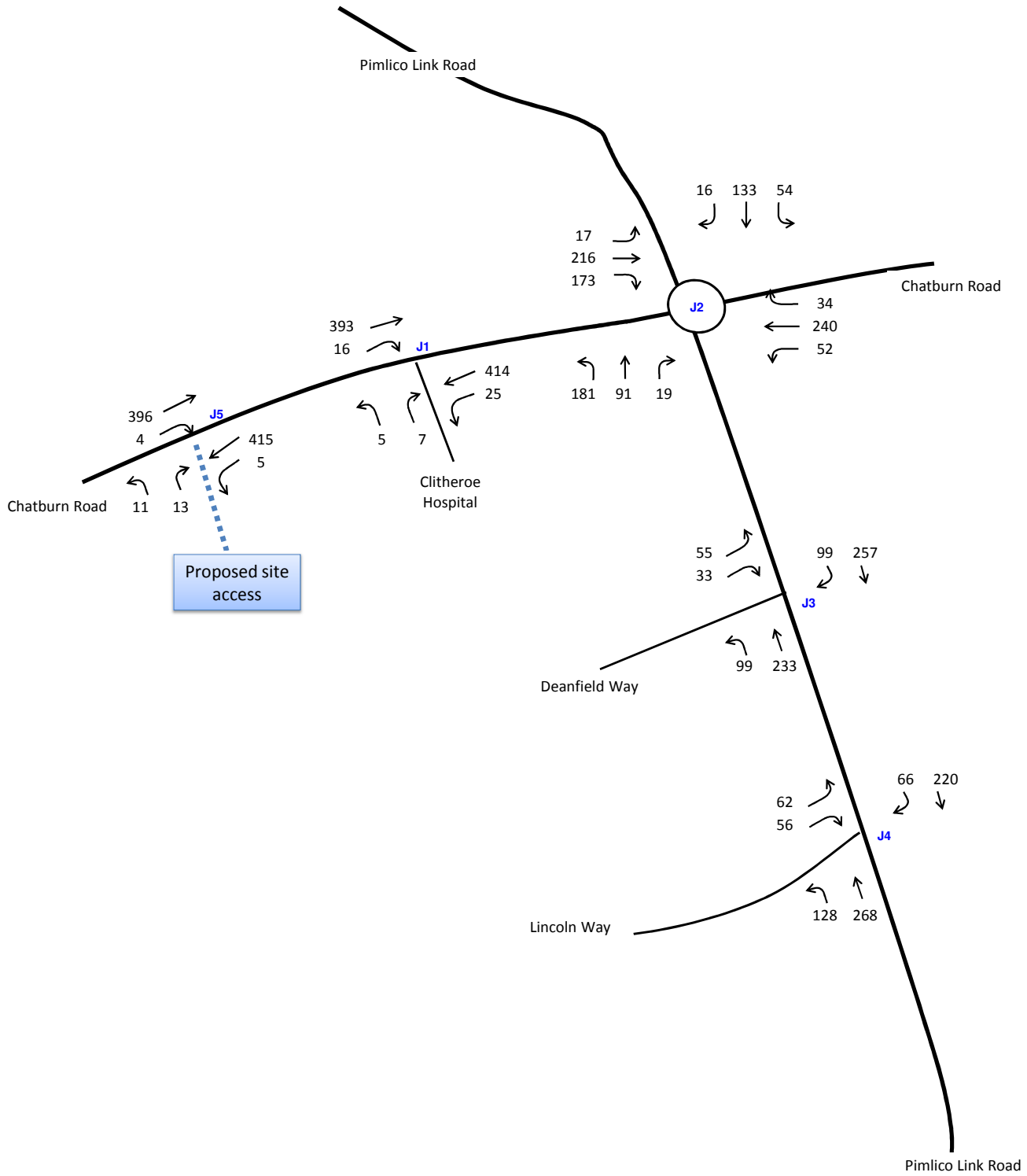


Figure 10: AM Peak Hour 2016 Assessment Flows

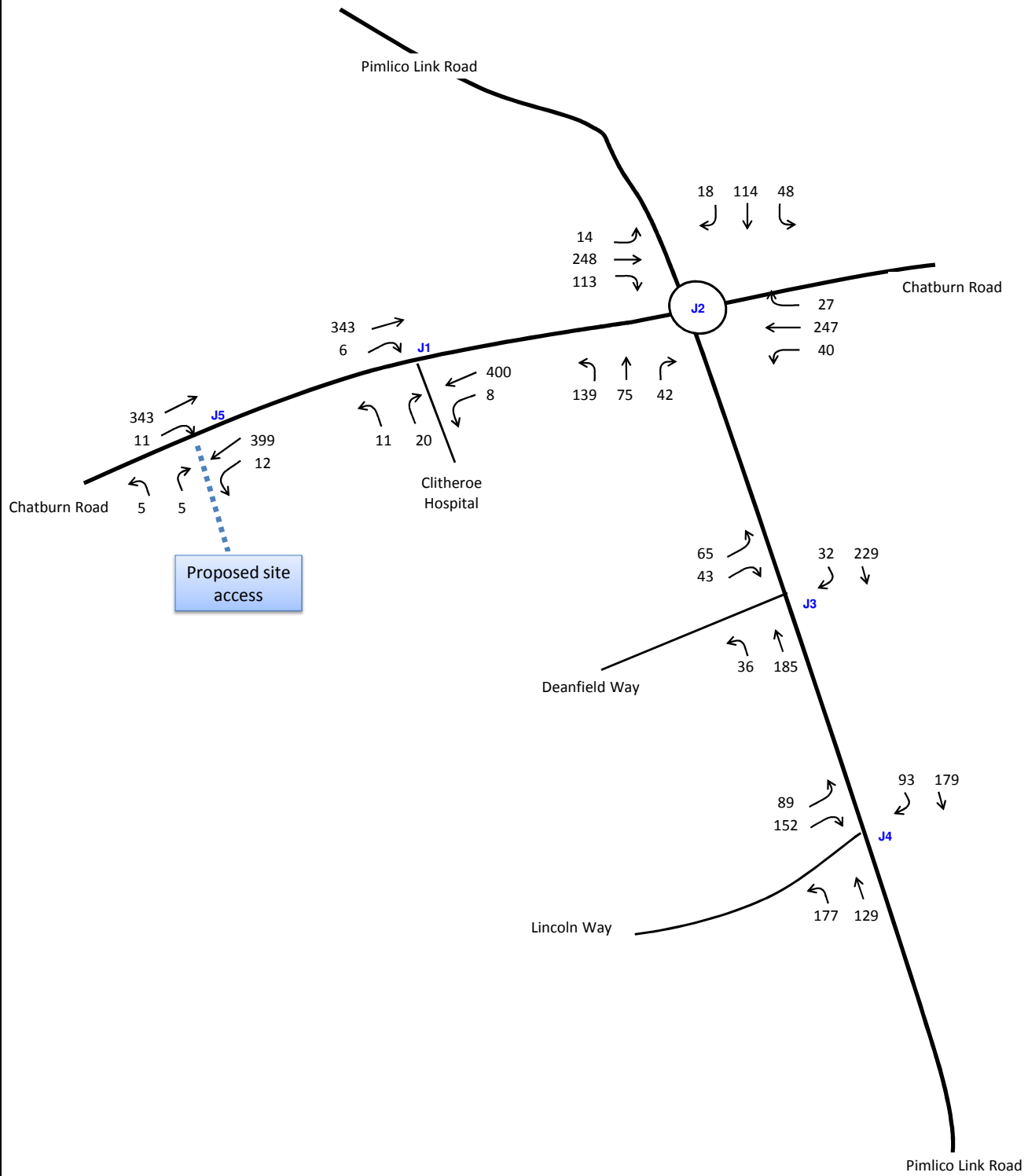


Figure 11: PM Peak Hour 2016 Assessment Flows

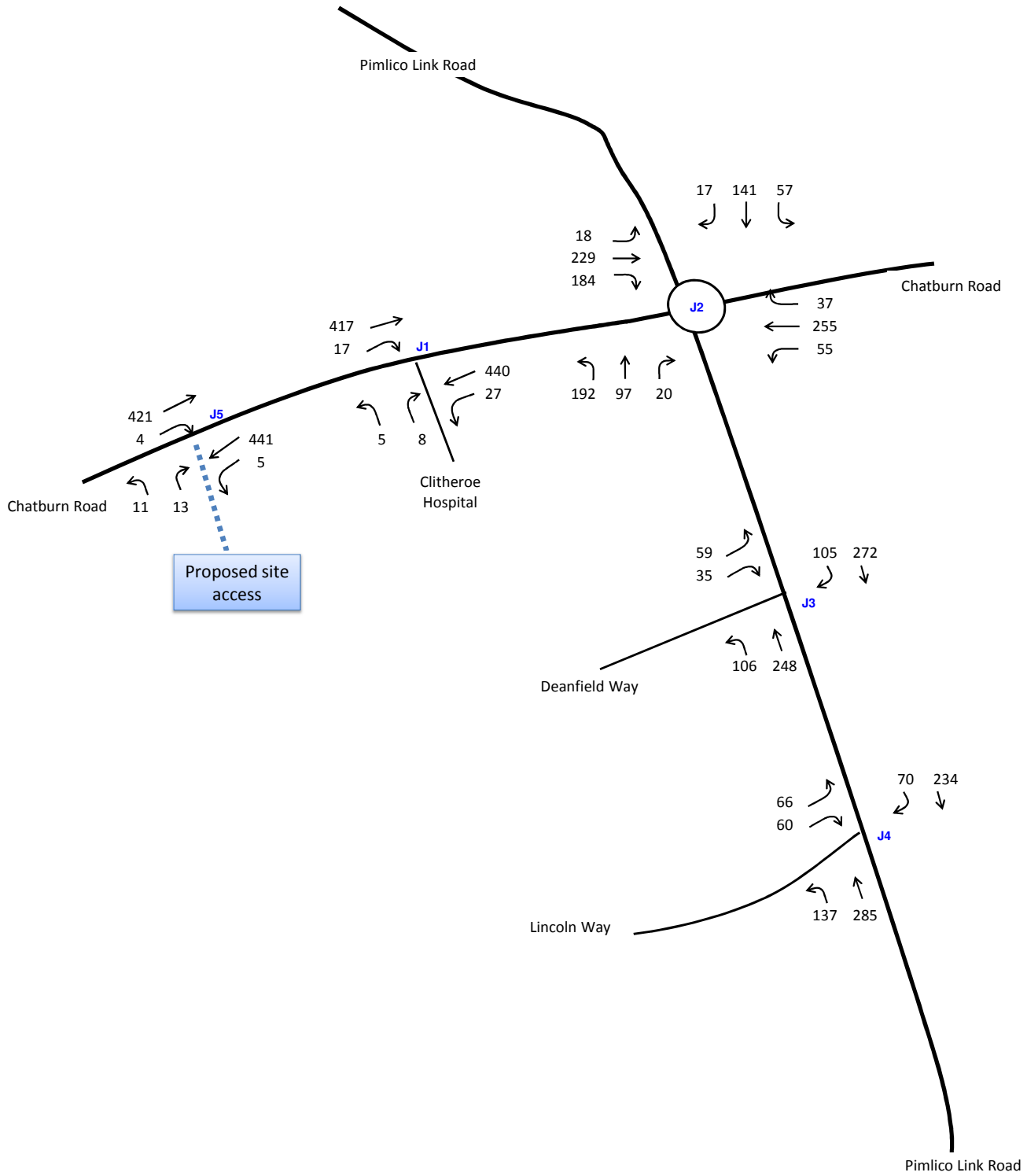


Figure 12: AM Peak Hour 2021 Assessment Flows



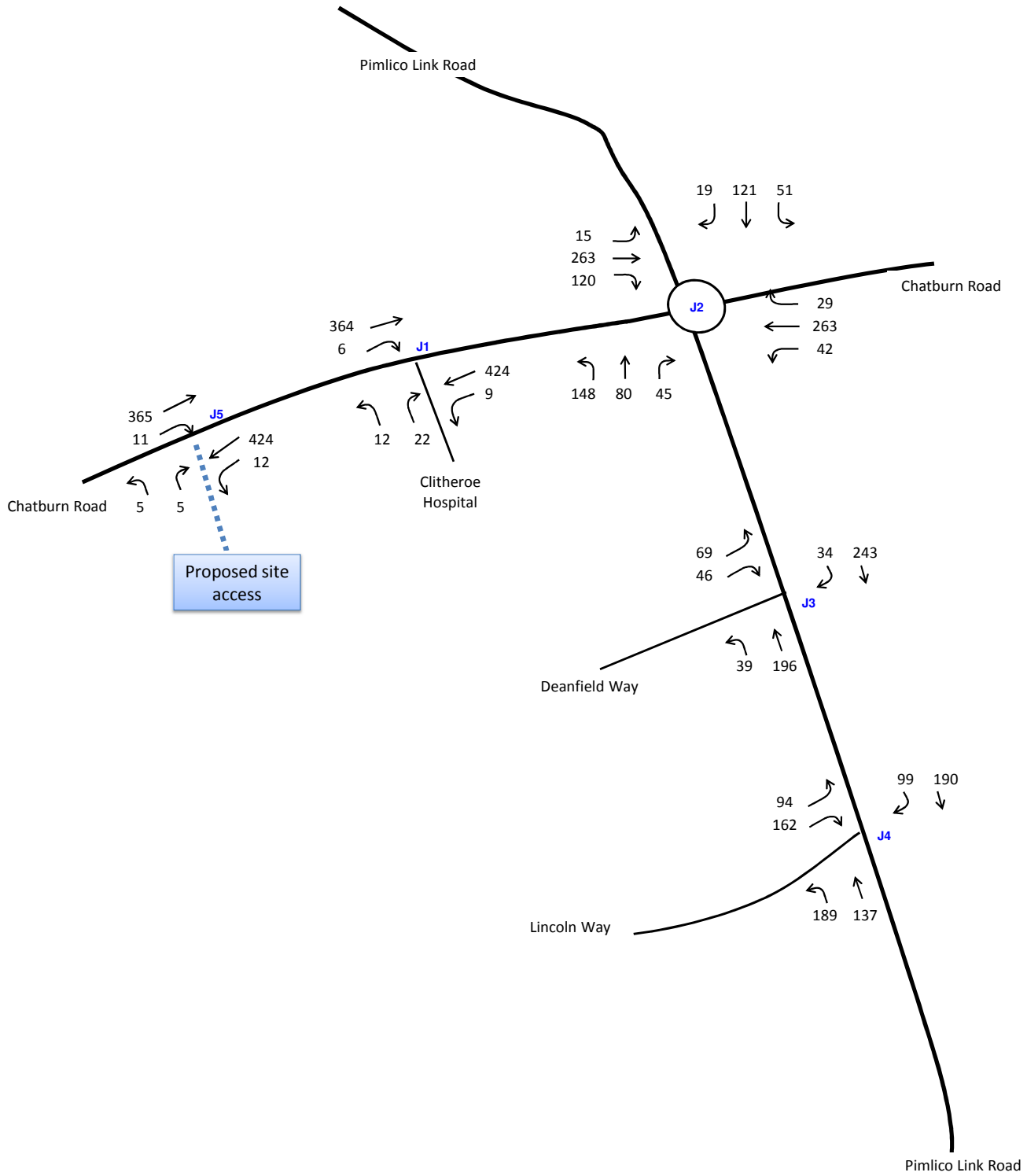


Figure 13: PM Peak Hour 2021 Assessment Flows

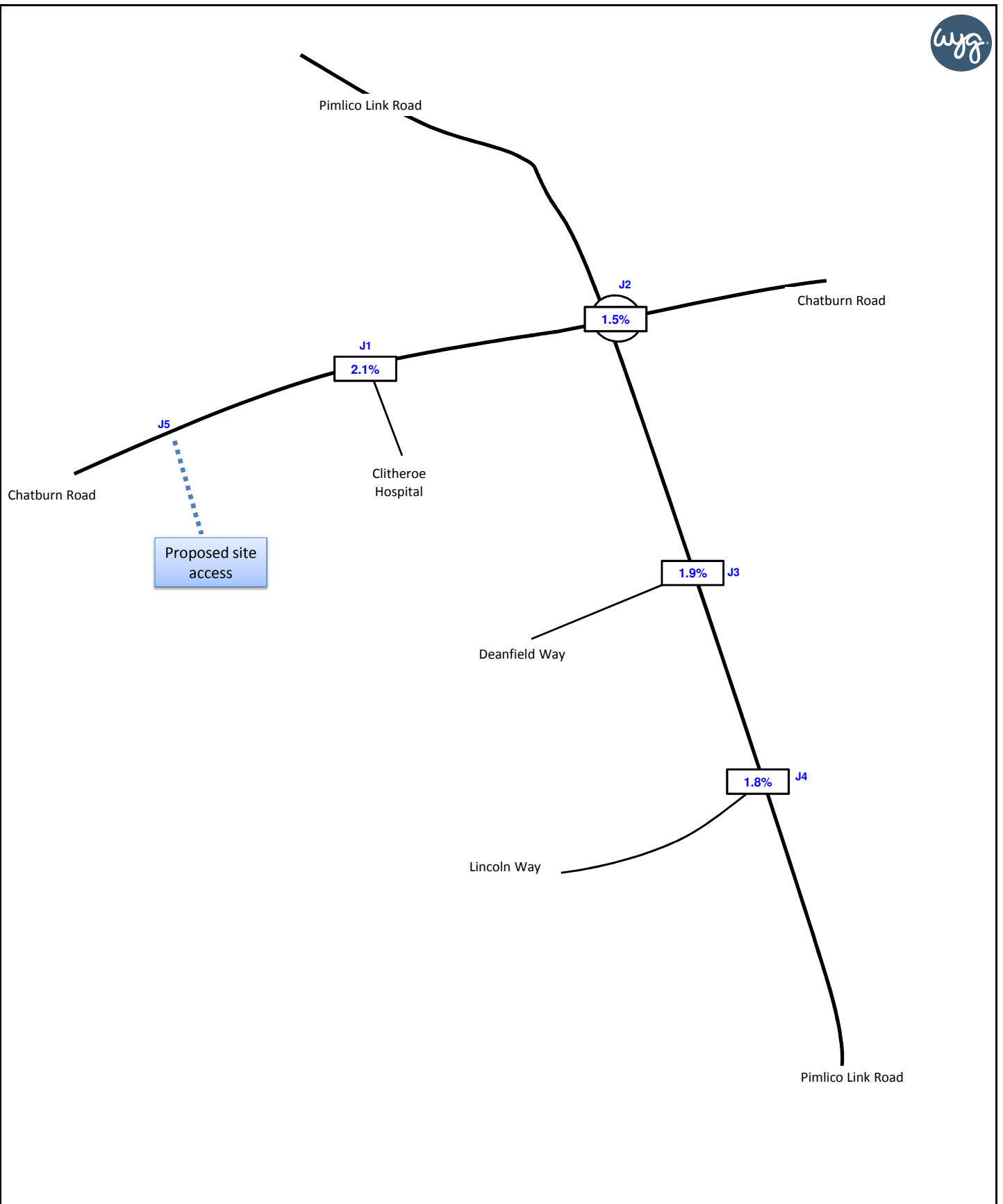


Figure 14: AM Peak Hour 2016 Traffic Impact (%)
