Location: 26 Holden Street Clitheroe BB7 1LU

With regard to the above planning application. In principal I would not have highway concerns with regard to the extension to No 26 Holden Street with exception to ensuring that the storage of household waste is confined to the garage space and this is not placed on the highway for any other reason than the periodic collection.

I would also need to be assured that during the demolition of the present toilet block and the construction of the extension that materials from the demolition and subsequent construction are not stored on the adopted highway. It should also be noted that if the construction work is to obstruct the highway including pedestrian areas then the correct permits are used.

I would not raise objections to this development on highway grounds subject to the following notes and conditions being attached to any permissions that your council is minded to grant.

Conditions

- 1. No building materials etc. associated with the development hereby approved shall be stored or placed on the adopted highway network prior to, during and following completion of construction of the proposed works. Reason: In the interest of highway safety.
- Rainwater from any roof or covering to the extension shall drain wholly within the existing site and shall not be allowed to discharge onto the adjacent adopted public highway network. (Section 163 of the Highways Act 1980 - Prevention of water falling on or flowing on to the highway refers.) Reason: In the interests of highway safety

Notes

- 1. This consent does not give approval to a connection being made to the County Council's highway drainage system.
- 2. In order to construct the external walls, the building construction work will extend into the highway and consequently this office should be notified of the proposed works before the development is commenced.
