I understand that the intention is to retain the marquee on site on a permanent basis as its use has become more frequent which is evident from the submitted list of uses this year. I understand that at the meeting you stressed the 'removable' nature of the marquee and how long it could potentially be present on the site without planning consent. Temporary structures can be present on a site for no more than 28 days in a calendar year without requiring planning permission.

However in this case, and whilst I appreciate that the marquee could be taken down at any point, its current retention on the site has certainly been more than 28 days and from the information submitted it is clear that it is in frequent use. Therefore the marquee constitutes as development and thus requires planning permission.

Historically, the the site for the marquee has always been used for recreation - it was indeed a grass tennis court prior to being owned by Girlguiding. In more recent years, it has remained a grassed area used for accommodating various tents and marquees during organised events, or for locating outdoor activity provision such as fencing. The site is located within the grounds of an Outdoor Adventure & Conference Centre and in viewing of a Grade II listed building known as Waddow Hall. It is located near to a crushed stone footpath from the main car park to the Waddow Hall building and is sheltered on one side by a small garden area with trees.
