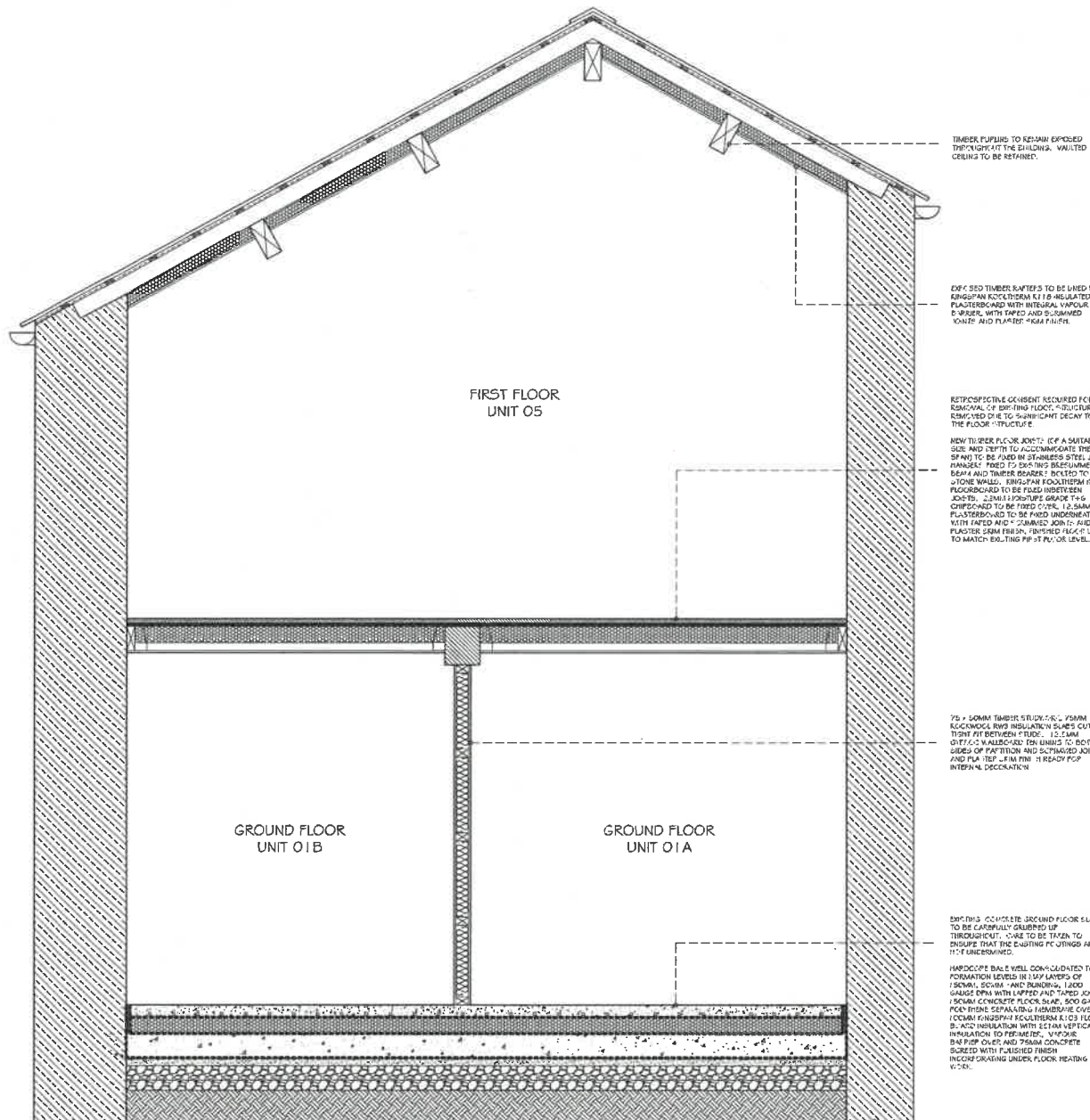

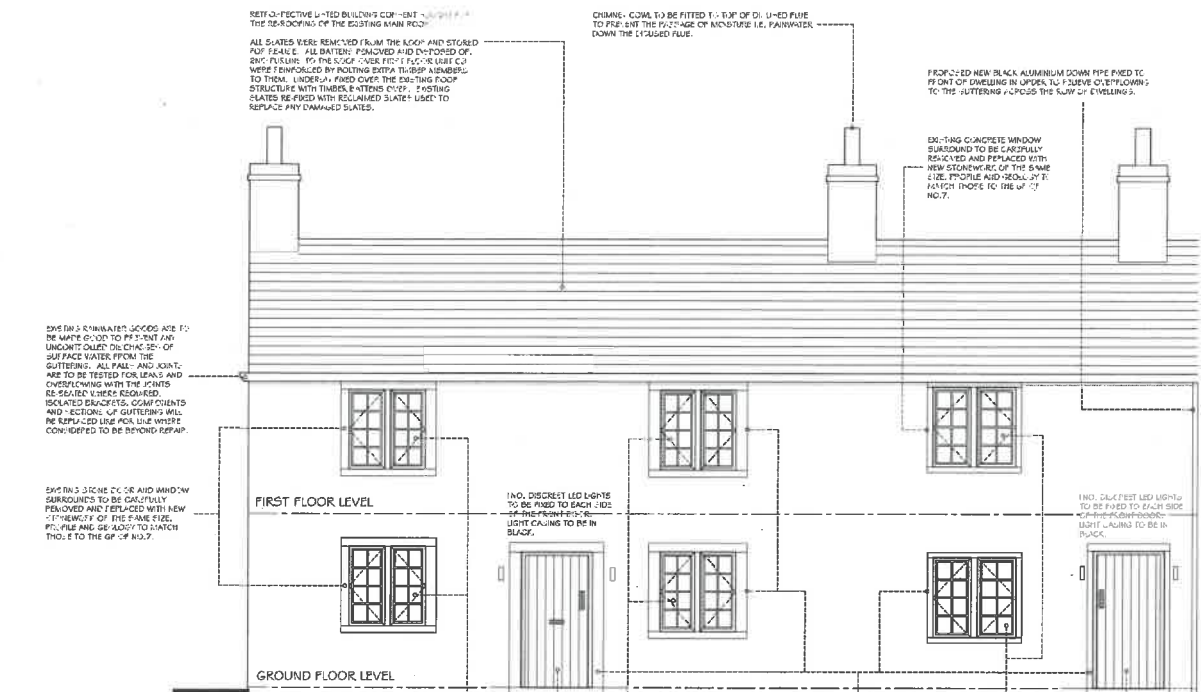

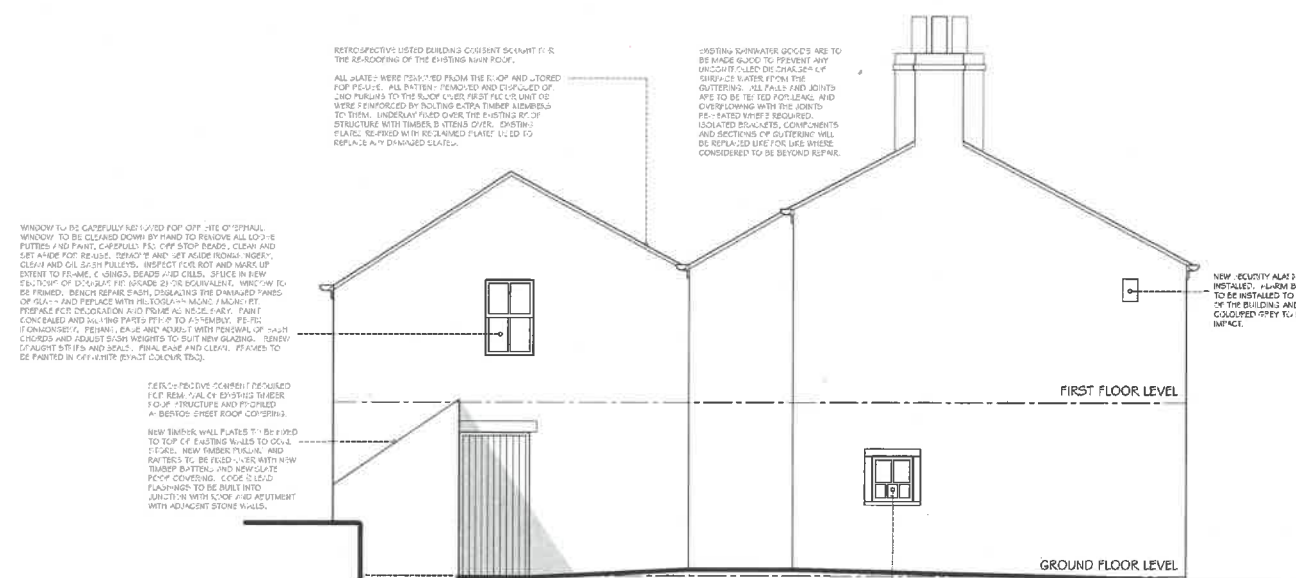

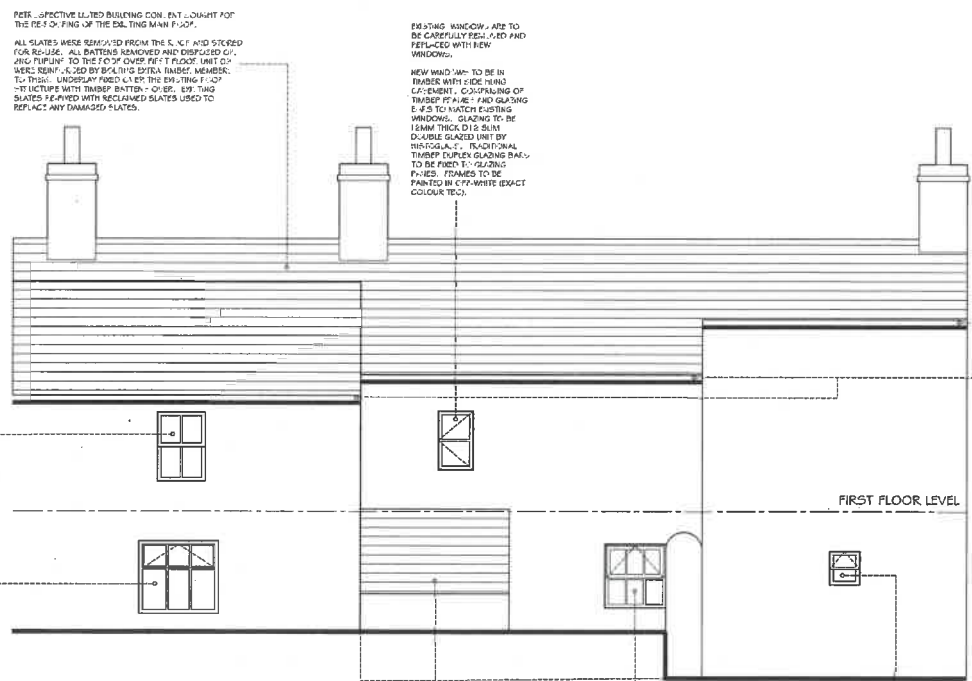

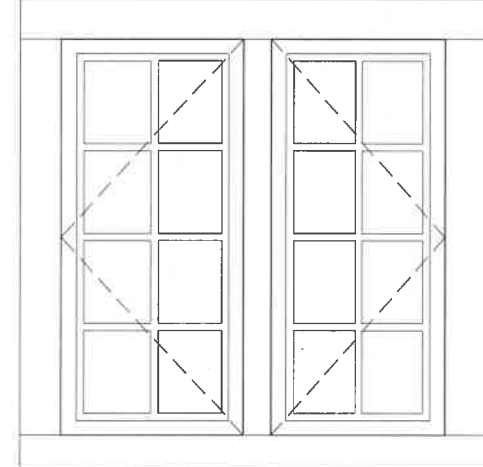
PROPOSED SOUTH-FACING ELEVATION



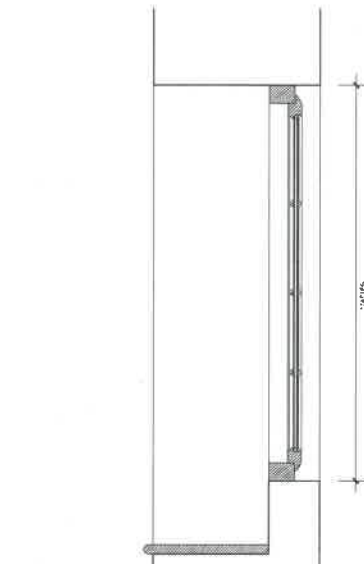
PROPOSED EAST FACING ELEVATION



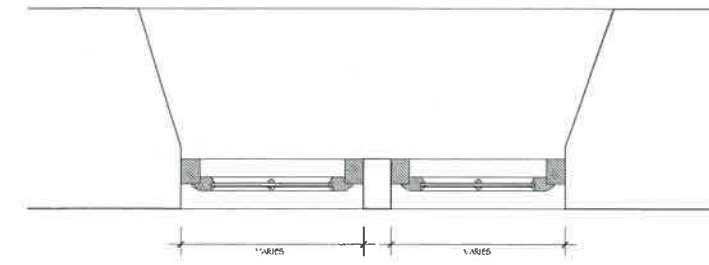

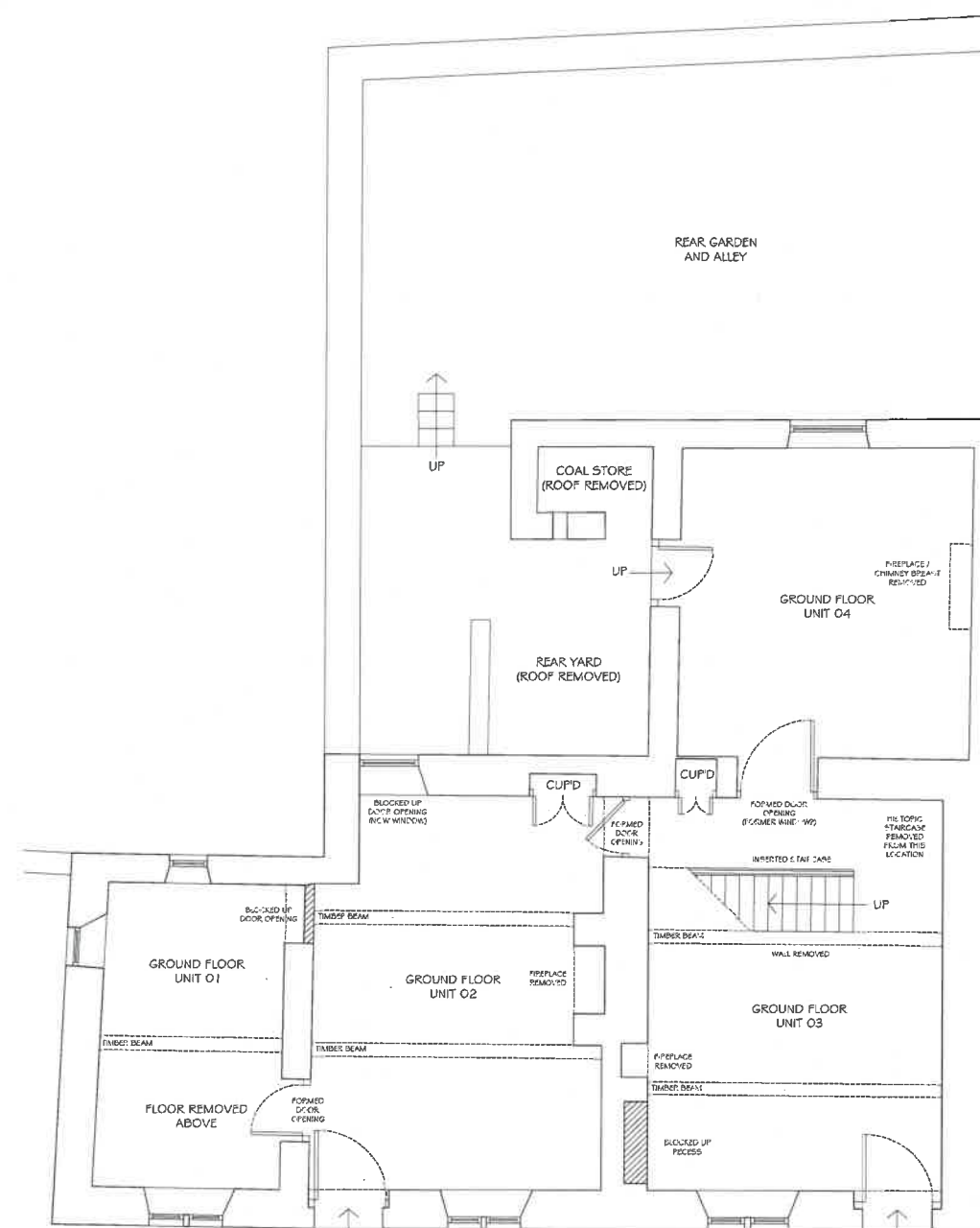
EXISTING SOUTH FACING ELEVATION

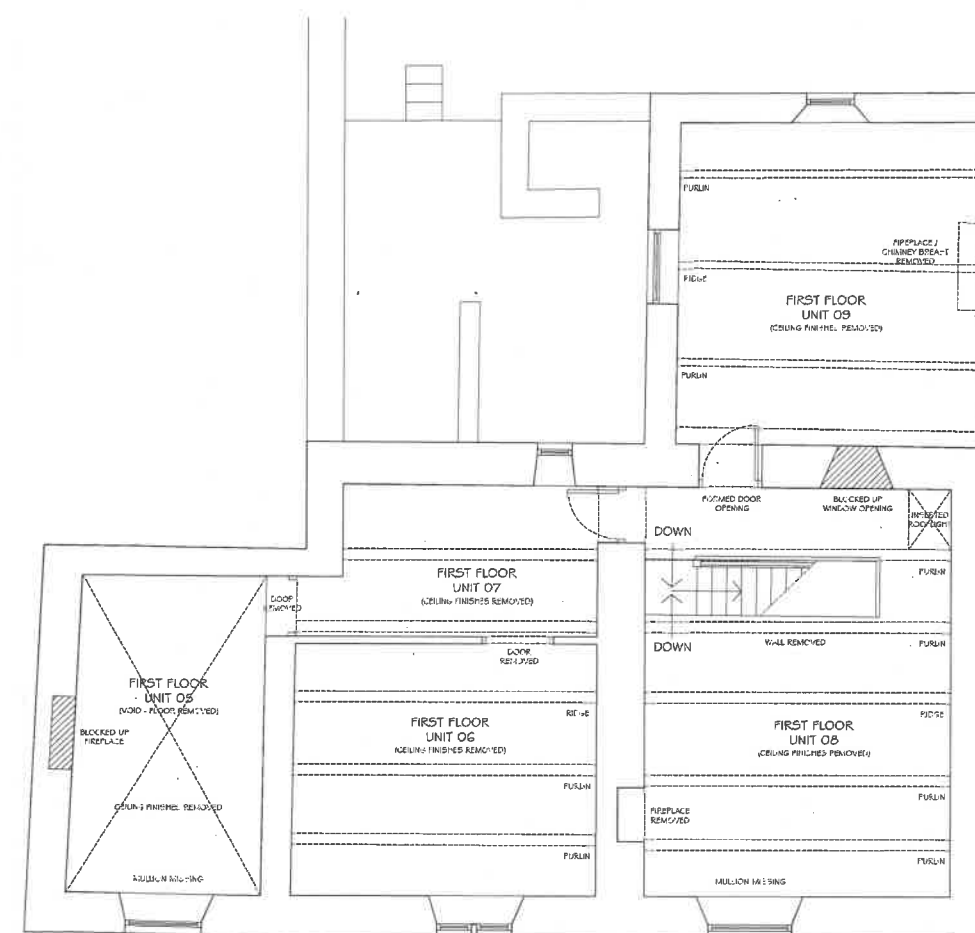
EXISTING EAST FACING ELEVATION
