"The principle of the proposed development is acceptable and in my view the site can accommodate a replacement building, subject to any increase in scale and massing being proportionate and final designs being appropriate for this rural setting. Key to the outcome of any subsequent application will be the demonstration that the development would not adversely impact the landscape character and will utilise materials and design features which are sympathetic to this site. As indicative 3D modelled designs have been submitted at this stage I cannot offer any detailed advice on those latter issues, however I believe that with the provision of appropriate information with a planning application, a suitable case can be made for the new buildings."
