Proposed garden room at the above address- flood risk statement.

We refer to the garden room proposal which is an addition to the existing house and landscaping which was last altered in 2009/ 2010 -see the attached flood defence consent CA 8157- grid ref SD 660 354. At the time of the landscaping the whole garden slope area down to the river was reprofiled and at the time the EA 1 in 100 year risk level was 26.18 just downstream of the EA node. This classed the existing house as floodzone 2 just above the Ribble 1 in 100 year risk level. The reprofiling produced a nett increase in existing floodplain volume below 1 in 100 year risk level of 102m3. Since then the Ribble river model has been revised and the 2010 version gives a 1 in 100 year risk level of 26.75 which is an increase and now classes the existing house as just in floodzone 3a.

The existing house has a slab level of 26.66 and the proposed garden room slab will be at 26.66 and also based on hard existing paving at a level of 26.4. This will make solid 23m3 of the 102m3 2009 gain and there will still be a nett gain from the property improvements. In terms of safety the area has a flood warning system which you should sign up to if you are not already receiving warnings and higher ground is just to the north of Ribchester Bridge.Should a serious Ribble flood occur and you wish to stay in the house then the upper first floor rooms are suitable but please note that a ribble flood can last several hours and maybe a day or so. A 1 in 1000 year risk level is 27.34.

In drainage terms the new roof area will be 66m2 and will be over an existing hard paved area so there will be no present day increase in runoff. However all new developments should comply with SC030219 'rainfall runoff management for new developments' and we advise that the new roof runoff discharges into a garden filter soakaway drain. This assumes the garden subsoil has some soakage potential and a 5m length trench 400mm width and 1m depth filled with 10-14mm pipe bedding plus a 100mm slotted uPVC land drain at the base should suffice as a soakaway. 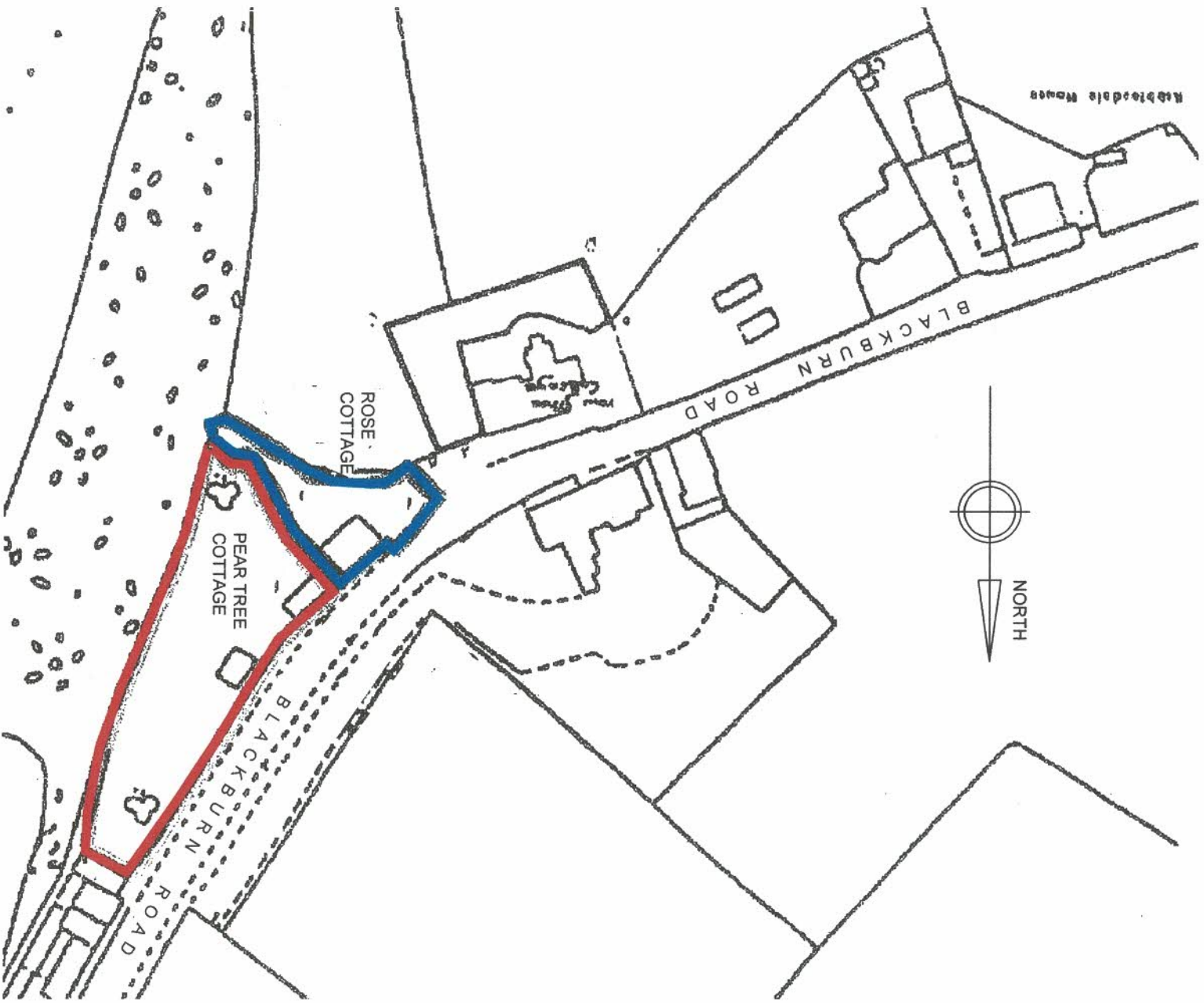

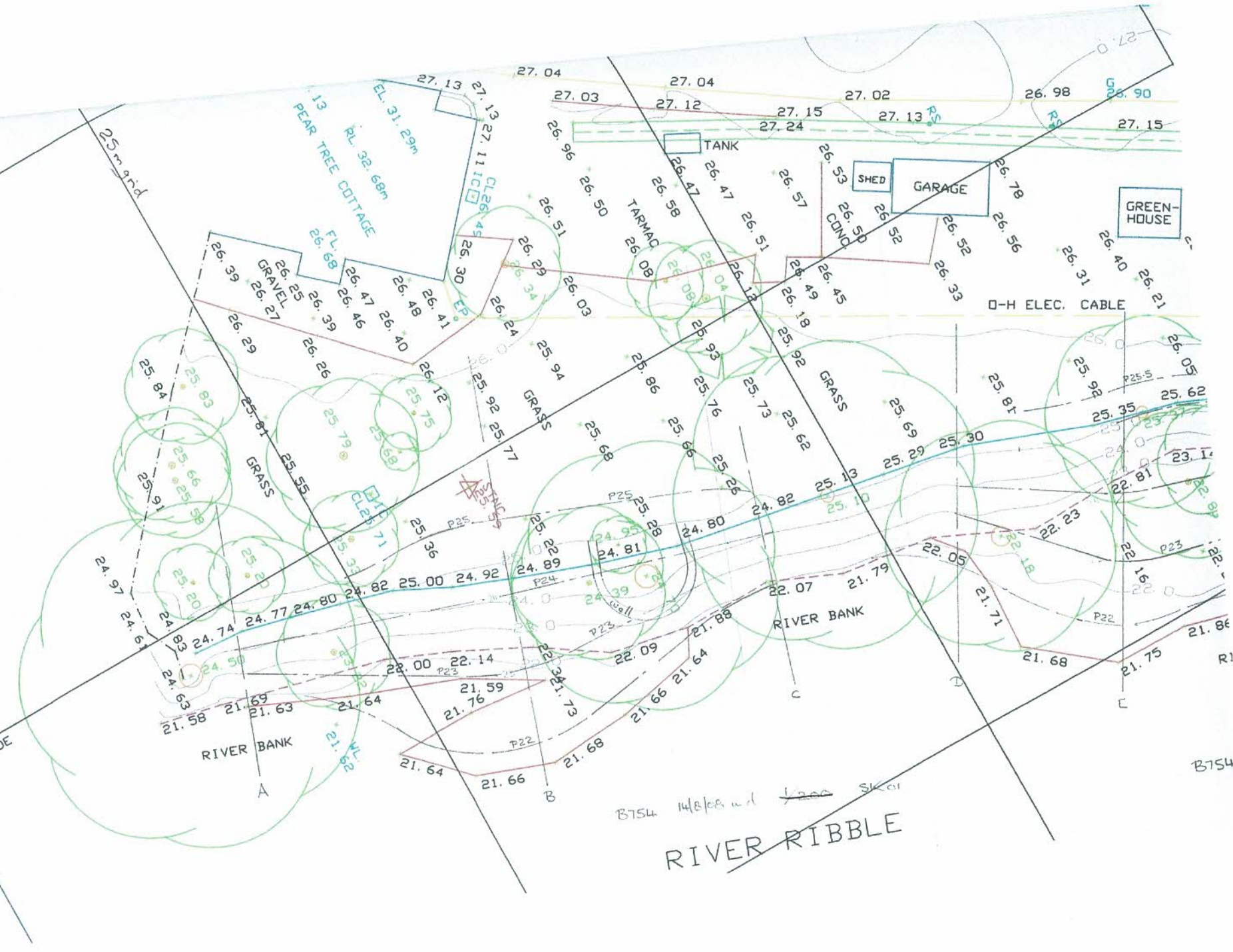

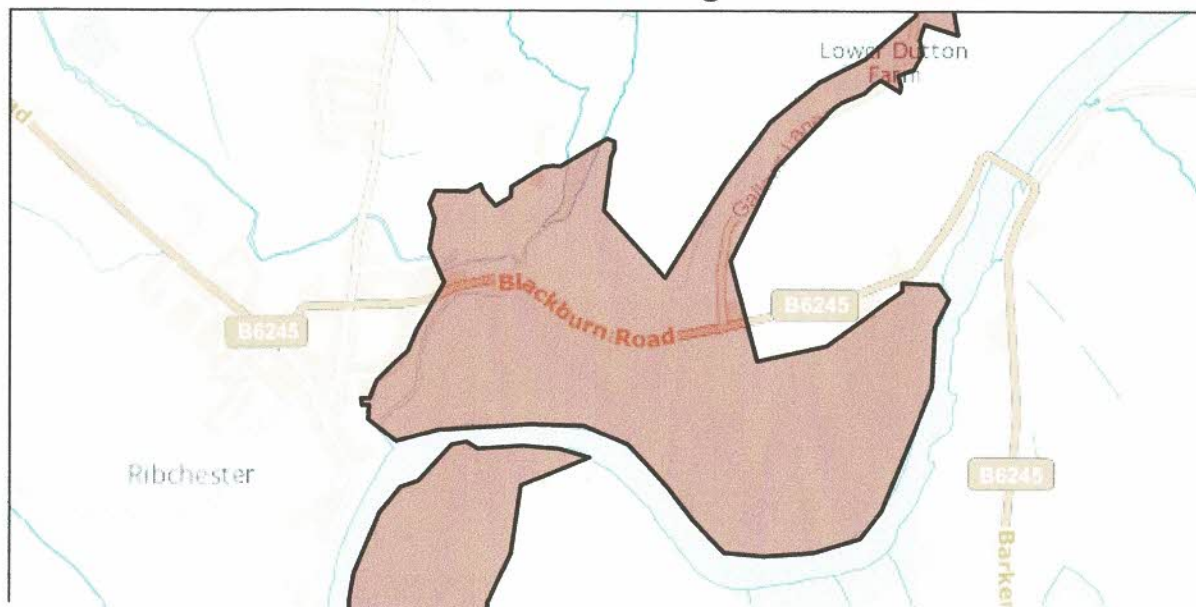
