Re-submission following refusal of application no. 3/2018/0826. Removal of existing partition wall between the ground floor study and WC and removal of existing sanitaryware to the ground floor WC to form larger study. Removal of existing balustrade and closing up of existing cellar entrance with a new cellar entry hatch to the floor. Insertion of full height glazed partition with double leaf glazed doors to the ground floor lounge. Relocation of the ground floor WC to below the existing ground floor staircase. Stripping out of partition, door and sanitaryware to the existing first floor WC and relocated WC to existing adjoining first floor bathroom and crating larger / wider landing. Removal of existing bathroom cupboards. Insertion of 4no. flush fitting conservation roof lights to the rear roof pitch.
