Dog Grooming Studio – 1 Moor Edge BB7 9RZ

3. Description of the Proposal

The Dog Grooming studio received a 12 month planning consent 25 May 2018 with conditions – app. No. 3/2018/0090.

This application seeks a permanent planning consent for the original proposal. The use permitted shall continue to be for the personal benefit of Ms Kelly Murphy, the applicant's daughter.

The property is a detached 2-storey dormer bungalow constructed of red brick under a tile roof, surrounded by similarly designed properties. To the rear of the property is a detached garage for which planning permission was granted in 1981.

The garage measures 4700mm x 6000mm and is split into two areas by a dividing wall each measuring 4700 x 3000mm.

There have been no external alterations.

The garage is constructed from concrete panels with a boxed galvanised steel roof and internal steel trusses. To the front of the garage are 2 car parking spaces and there are 3 additional parking spaces to the front of the dwelling. This off street parking is used to accommodate customers as required. There are existing dropped kerbs at both entrances to the property on Moor Lane and Moor Edge.

The applicant's daughter, who has a City & Guilds qualification in dog grooming, is operating the business, will continue to do so and will be the sole employee.

The hours of work are between 8am and 7pm, Monday to Friday with a maximum of 3 customers per day. There are very occasional customers on Saturday mornings between the hours of 9am and 1pm. All customer visits are by appointment only. There is a break between collection/drop off of dogs to allow for cleaning of the room in between customers. No customer's dogs are kept overnight.

During its operation from 1 June 2018 to date, many of the customers have arrived on foot as much of the customer base is local and as such, the impact on local residents and traffic users has been negligible.

Whilst the grooming business has operated in a predominately residential area, the scale and nature of the business is such that it has not had any impact on the residential amenity of neighbouring properties

It should be noted that a full and independent noise assessment was undertaken and submitted with the previous application.
