Hi Niall,

We guarantee that our tiles will conform to the specifications of BS EN 490 for 60 years, so your tiles are nearing the end of what we can confidently approve as their expected lifespan, but have a decade or so before that time is up. That being said concrete is quite a hardy material so they could potentially last much longer before any problems are experienced.

I would say replacing them within the next ten years would be advisable, but the choice is yours. Hope this helps!
