The two semi detached cottages which are the subject of the planning consent have been struttually complete since mid 2015.

Unfortunately the existing holiday let on site, Bowford Cottage, which is marketed through Hoseasons ,has experienced a steady decline in occupancy over recent years so much so that the demand is now down to as little as 20% per annum.

Furthermore the majority of occupants have been transient workers not holidaymakers.

Having waited now a number of years hoping for demand to improve it is now clear that the further investment to furnish and equip two further cottages is not financially viable under the present climate.

In view of the above senario it would appear more beneficial to look at long term lettings which requires the holiday let condition to be lifted.
