Construction will be minor consisting of excavation for the charging station bases and the base for the associated equipment. Finishing works include line and logo painting on allocated spaces for EV charging and cable laying for connection to the Grid. Main construction should be completed within 1 week.

The proposed development is for rapid electric vehicle charging stations. All equipment proposed for the site is below the permitted development height of 2.3 meters as per the amended Town and Country Planning (General Permitted Development) (England) Order 2015, Schedule 2, Part 2, Class E following the Government response to consultation on Planning Reform May 2019. The proposed development is not within any designated sites, scheduled monuments or the curtilage of listed buildings. Only 1 charging station is proposed per space and the charging stations are over 2 meters away from the nearest highway. The proposed development is minor in scale, using the latest technology for rapid charging stations while providing crucial low carbon infrastructure for the area.
