Eg. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

T952, T934, T935, T936 and T938 are mature horse chestnut trees located within the rear garden of 6 Brooklands, Chipping (see separate map of the trees). I consulted with Richard Davis of RMD Tree Care, who has seen Ken Linford's report (also attached), and responsible for felling T937 (which was badly diseased) for the previous occupant. He advised a light pruning of all trees, which hasn't been done for many years, to maintain their health and appearance, and lifting the crown to the first limb union (around 5-6 metres). He also recommended dead-wooding (or crown cleaning) throughout the canopy to ensure that branches that are showing dieback are removed.
