e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

We have owned the property for 7 years now. The garden of the property was overgrown and left unmanaged for many years and these three conifers were allowed to get too large for a small domestic garden and appear to have never been cut back to maintain a healthy appearance and shape. They have been competing for space and light with the large bank of trees running alongside as well as many scrubs that were also overgrown and competing for space. As a result the conifers have limited green growth around the bottom two meters in many places. The bottom areas have large bold areas where other shrubs has grown within them. Over recent years I have tried to slowly manage the trees removing shrubs hoping that the areas with no growth would possibly fill to make them look healthier and attractive. As is the case with conifers once they are allowed to get too big and not maintained any future trimming would result in no green foliage and just the brown area remaining. I therefore request the complete removal of these three unhealthy conifers. See supporting photographs and sketch plan for illustration.
