PROPOSED EXTENSION TO REAR OF EXISTING PRIVATE DWELLING TO FORM KITCHEN & DINING AREA.

THE PROPOSED SINGLE STOREY EXTENSION TO THE REAR OF THE PREMISES IS TO EXTEND FROM THE EXISTING MAIN REAR WALL TO THE REAR WALL OF THE EXISTING 2-STOREY OUTRIGGER.

THE NEW EXTENSION IS TO BE BUILT UP OFF THE EXISTING BRICKWORK BOUNDARY WALL BETWEEN 6 & 8 PARK AVENUE. THERE WILL BE AN ADDITIONAL 670mm WALL HEIGHT ADDED TO THE EXISTING WALL.

THE ROOF IS TO BE MONO-PITCH AT 22.5 DEGREES ABUTTING THE 2-STOREY EXISTING HOUSE.

THE HEIGHT OF THE PROPOSED EXTENSION HAS BEEN DESIGNED TO HAVE A MINIMUM IMPACT ON THE NATURAL DAYLIGHT TO THE ADJOINING PROPERTY, 8 PARK AVENUE. THE FLOOR LEVELS AT 8 PARK AVENUE ARE 750mm HIGHER THAN 6 PARK AVENUE.
