Reason: Tree is diseased; several ganoderma growing on top of tree, other fungus on ground level. Loose bark all around tree, tree no longer grows leaves.

Poses high risk to public safety and oncoming traffic as large branches snapping off tree onto main road.

Location: In rear garden / alongside public footpath and Whalley Road

Proposals: replace with 1 small beech tree in front or rear garden
