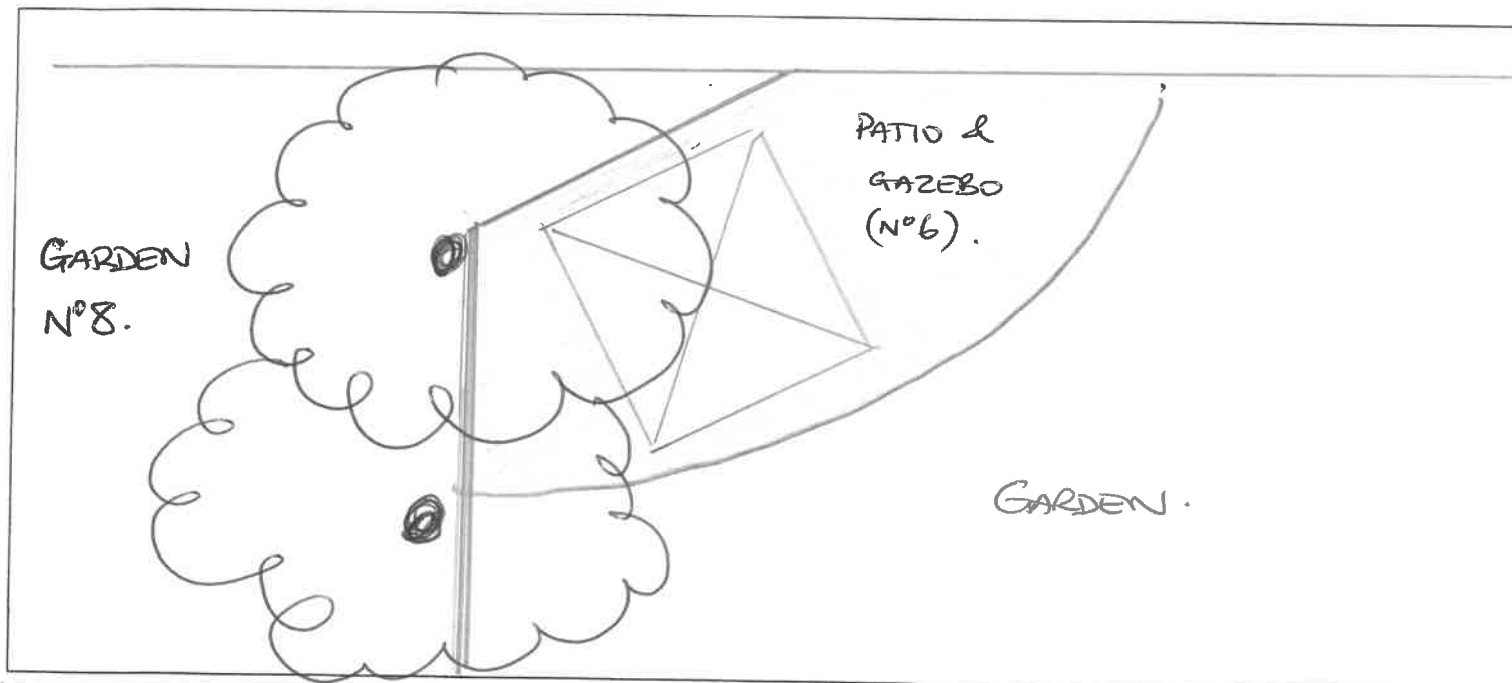

THESE TREES HAVE GROWN SIGNIFICANTLY OVER THE LAST 15 YEARS. IT IS REQUESTED TO:-

1. THIN THE CROWN (30%) 2. LIFT THE CROWN (10ft) 3. REDUCE THE CROWN (10ft)

THESE ACTIONS WILL RESHAPE THESE TREES TO A NATURAL SHAPE & REDUCE THEM TO A SIZE MORE APPROPRIATE TO THEIR PROXIMITY TO BOTH HOUSES. ALSO CUTTING AWAY MUCH OF THE OVER-HANG FROM N<sup>o</sup> 8 TO N<sup>o</sup> 6.
