I am writing this application up for Committee and attached the following condition as requested:

Prior to commencement of the development details shall be submitted to and approved in writing by the Local Planning Authority for a highway surface water drainage scheme including a timescale for implementation. The development shall be undertaken in accordance with the agreed details and the

scheme shown on the approved drawing shall be constructed in accordance with the approved details.

REASON: In the interest of highway safety to prevent water from discharging onto the public highway.

The agent has had some feedback from their Engineer as follows:

Condition 11 is somewhat confusing in that it refers to the 'highway surface water drainage scheme'. The Highway is beyond our site boundary and the responsibility of LCC. If it means 'surface water drainage scheme insofar as it affects discharge to the Public Highway', then we've addressed this in the Drainage Strategy. It would require a detailed drainage design to be approved pre-commencement, ensuring no water discharges onto the highway.
