e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 to T70- Phase 2 of Ash tree removal due to Hymenoscyphus Fraxinus disease.

In 2020 the Ash trees in the most advanced stages of Ash dieback disease were identified and felled, totaling 85. The remaining trees were left to lessen the impact to the woodland.

Having been monitored throughout the summer of 2020 the remaining Ash trees have rapidly declined, these trees are now marked with green marker paint on site for the ease of identification.

Number to be felled totals 70 trees.

Once the felling has taken place this will allow for a re-planting scheme of native species.

A total of 155 trees will have been removed with a planting scheme to re-plant 200 trees in the planting season of 2021-2022.

No re-planting has yet taken place from the 1st phase of felling as they will simply be damaged in the further removal of the remaining Ash trees.

All the trees are located within the red outlined plan within the application
