Details of the pre-application advice received

The conclusion for this pre-app was there was a requirement to first address the unlawful change of use of agricultural land to residential use through the submission of a Certificate of Lawfulness prior to an application for planning consent for the erection of an annex. This was done successfully under Application 3/2020/0481. In relation to the scale and design of the proposed annex building, it was suggested that the height of the annex is reduced to "provide single storey living accommodation of a modest nature." As shown on the drawings this has been taken on board in the planning application with the eaves & ridge height of the annex being the same as the parent property.
