The partitions being demolished are relatively recent as other plans indicate. The present arrangement does not comply with disabled access requirements and the practical use of the dwelling is impaired by the narrow entrance lobby and access corridor. The dwelling is in a flood risk area and has been flooded twice in recent years. High levels of condensation are an issue and as a result there is deterioration of timber windows and doors.
