Please describe the proposed works:

Fitting of 3 x rooflights onto the south facing roof elevation. The rooflights will be grey in colour to match the existing slate finish and will not project more than 150mm from the existing roof plain, they will also be set below the highest part of the roof whilst ensuring they will be more than 1.7m above floor level. (If required obscured class can be fitted, however this has not been a requirement of neighbouring property's). This would be in keeping with the surrounding three homes (there are only three homes in near vicinity) two of which have them facing on the same southerly elevation and have been granted permission with no objections and one westerly elevation again with no objections. (Applications: 3/2017/0841, 3/2006/0934, 3/1997/0459) It may be of note that the construction would generally fall within permitted development rights.
The southerly elevation is chosen as it is not overlooked by any neighbouring property's, the nearest home on the southerly elevation is around 400m away. The northern elevation would be directly overlooked from neighbouring property, therefore this would not be appropriate. The fitting of rooflights would also allow for the greatest health & environmental benefits, directly lighting the living space within the home, also reducing the carbon impact due to the reduced powered lighting needs.
