T5 - Downy Birch - Dead tree- Remove

T6 - Common Ash - Remove tree due to identified increased risk of stem failure at base.

G1 - Birch Oak Sycamore - Remove Oak to west of group due evidently progressive subsidence towards low voltage overhead power line.
