In addition, there is a ~~tree~~ cable? from across the street that passes through the trees to the left of the front of the property, therefore, a clear "index" cannot be required as the branches require some thinning to ensure no interference. The attached diagram highlights 3 trees designated as "Important trees" to the front of the front of the property, while the trees on the road side require some crown lifting, the height of the trees suggest further back, require crown reduction as the height is significant in response to the height of local properties. The height is such that it appears to pose a potential risk of falling if strong winds are encountered. If further information is required, please post request to nearest the same.
