It is considered that the principle is acceptable and subject to minor design changes and justification the siting and scale of the development is likely to be appropriate. As discussed it would be useful to submit a design justification for modular building and photographs of where it has been used on previous sites.

Although unable to fully comment on highway matters I would advise that secure cycle storage as well as electric charging points be provided within the site. I would suggest that the Planning Statement refers to Transport Assessment indicating that the proposal would not generate additional pupils and likely traffic movements.

In relation to impact on the setting of the Clitheroe Conservation Area and adjacent Listed buildings I would suggest that a Heritage Statement be submitted and that it incorporates the public benefits associated within the scheme.

As discussed the scheme would need to take into account the advice of the Lead Local Flooding Authority and include the necessary information to allow an adequate assessment.

As well as the details you refer to in your pre app submission I would also ask that a section through the site showing the relationship of the new building with the existing school, a Heritage Statement and an Arboricultural report be included in any application.

I understand there are time pressures so I would suggest it would be helpful if you could include the details so I can be aware of the need of the dates so if at all possible I can ensure that there is no undue delay.
