5. Flat top edgings to be installed at back of all footways unless stated otherwise.
6. For radii of 12m or less, purpose made radii kerbs are to be used.
7. Kerb face for Vehicular Crossing = 25mm
Kerb Face for Pedestrian Crossing = 6mm (maximum)
