Background

The Local Highway Authority (LHA) are in receipt of a discharge of conditions application for Conditions 6 (Construction Method Statement) and 7 (Scheme for Retaining Structure) of planning application 3/2020/0885 at Overdale, Dilworth Lane, Longridge.

The LHA previously responded to the application on 3rd November 2021, objecting against the Discharge of Condition 7 requesting further information regarding the retaining wall. The Agent has therefore sent revised plans which will be analysed below.

Condition 6

"No development shall take place, including any works of demolition, until a construction method statement has been submitted to and approved in writing by the Local Planning Authority. The approved statement shall be adhered to throughout the construction period. It shall provide for:

- O The loading and unloading of plant and materials*
- O The storage of plant and materials used in constructing the development*
- O Measures to control the emission of dust and dirt during construction*
- O A scheme for recycling/disposing of waste resulting from demolition and construction works*
- O Details of working hours*

Reason: In the interest of protecting residential amenity from noise and disturbance and to ensure the safe operation of the highway."

Highway Comments:

The LHA have reviewed the Construction Management Plan and are satisfied that the site complies with the LHAs guidance and so have no objection to the discharge of condition.

Condition 7

"No part of the development hereby approved shall commence until a scheme for the retaining structure adjacent to the highway has been submitted to and approved by, the Local Planning Authority.

Reason: In order to satisfy the Local Planning Authority and Highway Authority that the final details of the retaining structure are acceptable before work commences on site."

Highway Comments:

The LHA have reviewed the supporting documents and are satisfied that the site complies with the LHAs guidance and so have no objection to the discharge of condition.
