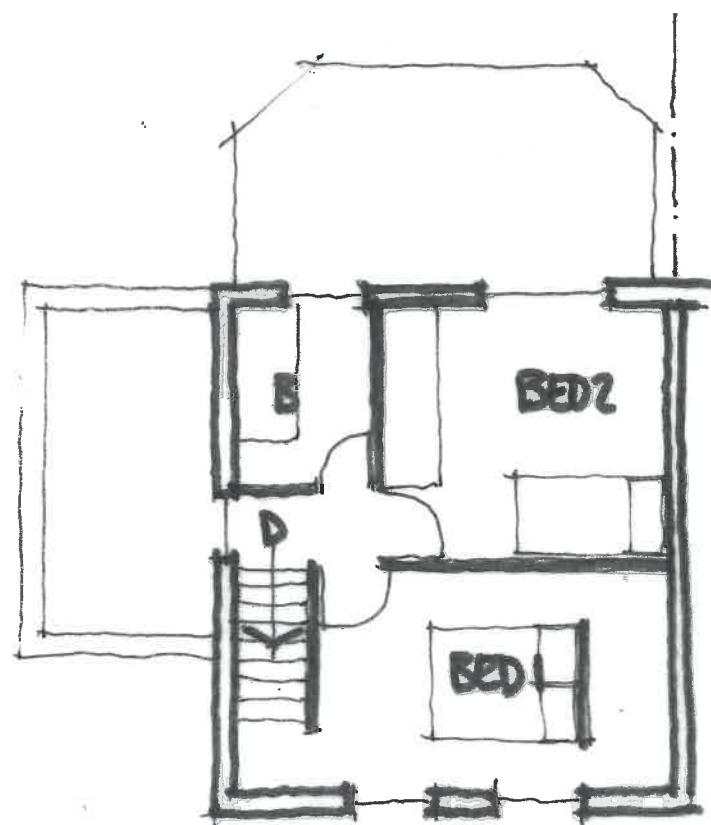
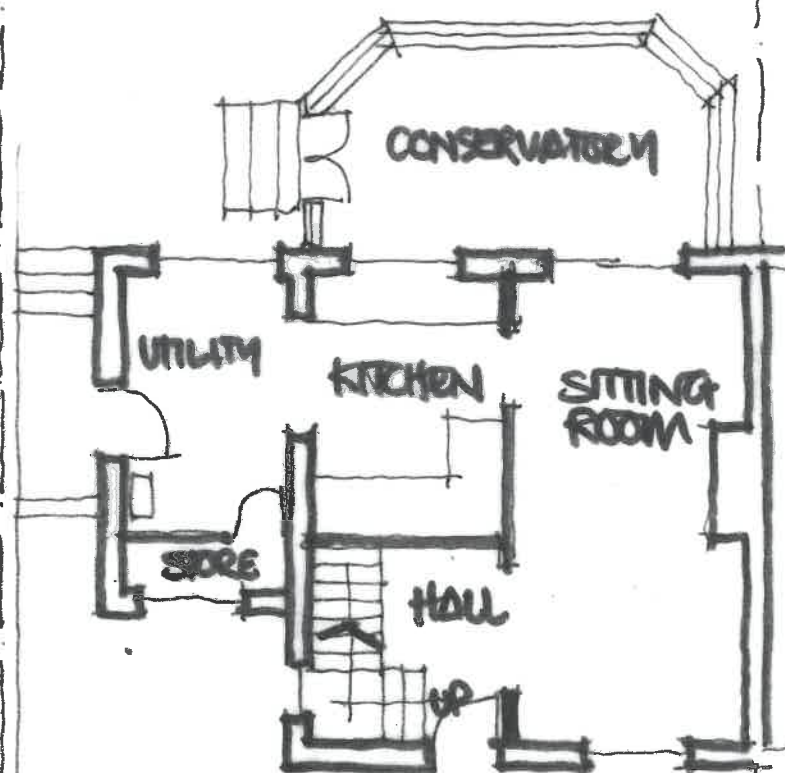

EXISTING FIRST FLOOR PLAN.



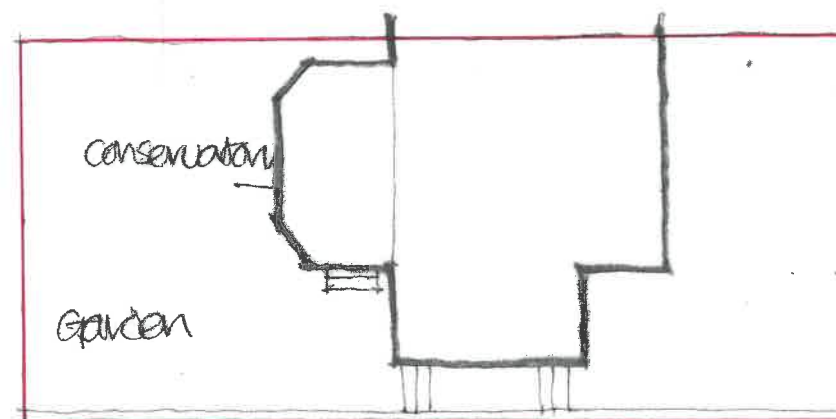
EXISTING GROUND FLOOR PLAN

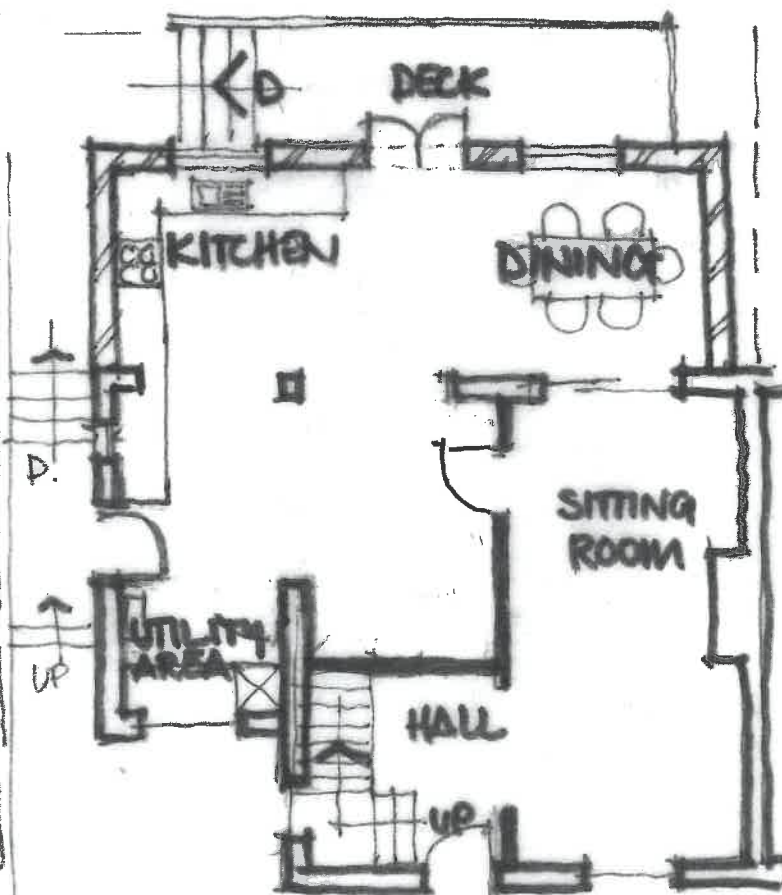

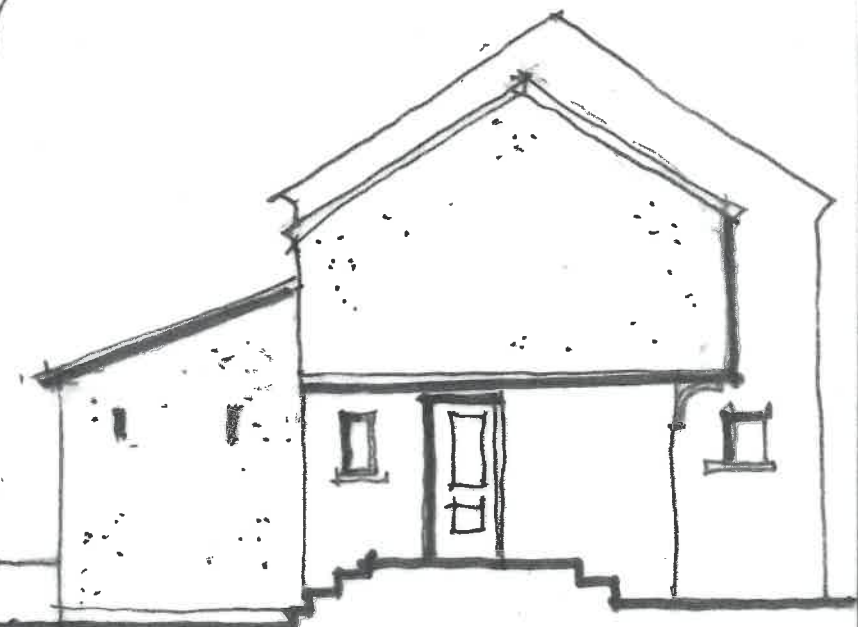
