TREE 1, WHITE CEDAR APPROXIMATELY 8m HIGH IS LOCATED IN THE FRONT EASTERN GARDEN, THE ROOTS HAVE LIFTED THE PAVING ON THE MAIN ENTRANCE PATH PREVENTING CLOSURE OF THE GATE. THE SPREAD HAS PREVENTED ACCESS TO THE PATH AROUND THE GARDEN.

TREE 2, LAWSON CYPRESS APPROXIMATELY 15m HIGH IS LOCATED IN THE NORTH WEST CORNER OF THE UPPER GARDEN OF NUMBER 5 IN VERY CLOSE PROXIMITY TO THE HEAD OF A RETAINING WALL TO THE LOWER GARDEN. IT HAS CAUSED SIGNIFICANT CRACKING AND OUTWARD MOVEMENT OF THE RETAINING WALL. A LARGER CYPRESS WAS PREVIOUSLY LOCATED TO THE EAST OF TREE 2 FORCING IT TO GROW IN AN UNBALANCED FORM, THE ADJACENT TREE FELL A NUMBER OF YEARS AGO LEAVING TREE 2 HEAVY TO THE WEST. SEE ATTACHED AERIAL PHOTOGRAPH.
