Lawson cypress (T8)- Fell to ground level. Included bark union at approx. 2 metres above ground level with signs of failure, within falling distance of school access road. Replant with heavy standard Oak/Hornbeam/Lime.  
Lawson cypress (T18)- Crown reduce by 50%. Neighbour concerned regarding overhang into their garden and impact on light into rear garden/dwelling.
