Chipping Football Club use and maintain the community asset Chipping playing field during and out of season, and we contribute to the use of the Village Hall's MUGA facility.

The club have informally canvassed the area to seek out any objection or amendment to our proposal and met with no resistance only support.

I have conducted a random door knocking exercise where I asked for peoples support in the form of a signature which was well supported.

Chipping Parish Council (CPC) manage the community asset Chipping playing field. CPC recognise the value of the football club to their community with 250 members from reception to senior players. The CPC have not historically approved of large permanent signs on main roads within the village as they did not believe it to be in keeping with the aesthetic of the village, however they confirmed after consultation that they believe the signs around the perimeter of the football pitch are appropriate, with the outside facing boards being green with the branded advertising looking inwards to the pitch. The CPC in their discussions and decision balanced the concerns of some parishoners regarding the visual impact of advertising on the field within an AONB, and the importance of the sustainability of the football club as an asset to the village.

I have approached the local parish council and after a meeting to discuss they voted to support out motion.
