3. Description of Proposed Work

Please describe the proposals to alter, extend or demolish the listed building(s):

Repairs to roof of one storey extension at gable end (originally built 1984 with planning permission from RVBC). The roof is no longer watertight and we have had many problems with it over the years. We are advised that the slates used are too thin (and therefore crack very easily) and were installed in 1984 with insufficient overlap. Accordingly they are no longer fit for purpose and will need to be replaced.

The work to be done therefore will involve replacement of the current slates (which are 'firsts') with Welsh blue slates which are 'thirds'. The slates to be used will be chosen to provide best match with the existing slates on the main roof of the house.

It will also be necessary to replace the laths. Finally, the existing plastic membrane (from 1984) will need to be replaced with a modern breathable felt in line with Building Regulations.
